

Dear Mr. Johnson:

I am writing on behalf of Robert Pollard in connection with your joint ownership of the T-G No. 1 Placer Claim located in the northeast quarter of section 32, range 1 west, township 11 north, and more generally located in the Turkey Creek area. As you are well aware, in April of 1976, you, Robert Pollard, and Marie Johnson executed and filed a notice of mining claim location for the above referred placer claim. It is my understanding that Bob's name was included on the claim notice by virtue of the assessment work and caretaking he has provided with respect to that claim.

Since the filing of the location notice, Mr. Pollard has discovered that you have attempted to amend your mining claim location notice by deleting Mr. Pollard's name from the location notice. However, in so doing, you never obtained the permission or consent of Mr. Pollard, nor did you file any kind of legal document evidencing the proper conveyance of Mr. Pollard's interest back to you.

I have reviewed the situation with Mr. Pollard, and have advised him that you have no legal right or authority to remove his name from the mining claim location notice. I have advised Bob that if you do not voluntarily correct the situation, he should file suit in partition and quiet title in Yavapai County directing that the court sell the claim, and divide

You simply cannot do what you have done, Mr. Johnson, and in addition to the sale of the mining claim, we would ask for recover of our costs and attorney's fees in correcting the cloud which you have created on the interest which Mr. Pollard holds on the above mining claim.

In order to avoid legal action over the above, we would consider a compromise whereby Mr. Pollard's interest in the claim would be segregated and set apart along the southerly one-third of the claim. If we do not here from you in the next ten days, however, appropriate legal action will be taken.




