## ANNUAL MAINTENANCE FEE AND MINING CLAIM LOCATION FEE HAVE INCREASED

The annual maintenance fee for mining claims has increased from \$125 to \$140 per claim. The maintenance fee for the 2010 assessment year is due to BLM on or before September 1, 2009. If you have already paid your 2010 maintenance fee payment, you must send in the additional \$15 per claim prior to September 1, 2009.

Also, the location fee for new mining claims has increased from \$30 to \$34. Any new mining claims located on or after September 1, 2009, will cost \$189 per claim. This includes a \$34 location fee, \$140 maintenance fee, and \$15 processing fee.

This change in mining claim fees is in accordance with 30 U.S.C. 28j(c), which authorizes adjustments to the location and annual maintenance fees "to reflect changes in the Consumer Price Index published by the Bureau of Labor Statistics of the Department of Labor every 5 years after August 10, 1993, or more frequently if the Secretary determines an adjustment to be reasonable." The BLM has not adjusted the location and maintenance fees since 2004.

The fee adjustment is published in the Federal Register dated June 29, 2009. Copies of the rule are available from BLM State Offices and its Washington, D.C., Office. The text is also accessible on the Federal Register Web site (<a href="www.access.gpo.gov">www.access.gpo.gov</a>) and is available for public viewing at the Office of the Federal Register.
