
I also noticed that someone has been excavating our tailing pile at the ponds below the St. Louis. I would like for you to cease doing any work on my claims.

I am assuming that you mistakenly filed this claim over mine and that you don't have any malicious intent of jumping someone else's claim.

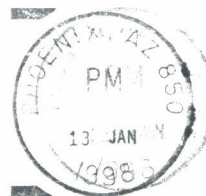
