
On June 1, 2009, 16 Quit Claim Deeds (QCD) were received by the Arizona State Office, Bureau of Land Management (BLM), transferring 22 claims from Nature's Beauty Unlimited, LTD, ZPower Technologies LTD, Natural Stone and Minerals LLC , James Varney, Roy Arthur, and Nature's Beauty Unlimited LLC to Duell and Company, Inc.

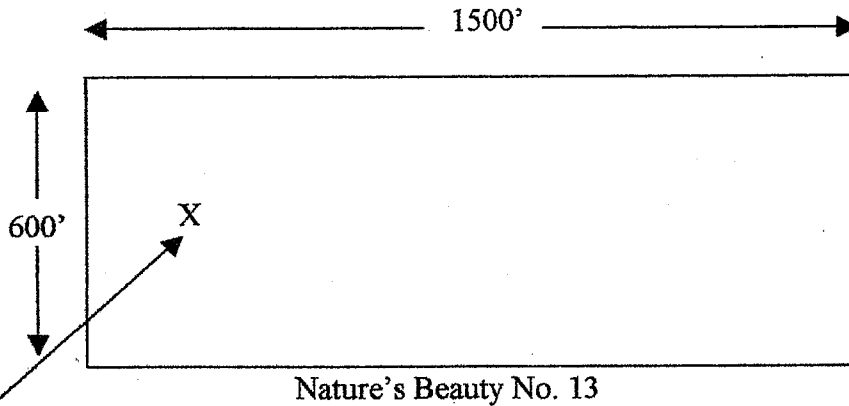
