## ANNUAL MAINTENANCE FEES AND MINING CLAIM LOCATION FEES HAVE INCREASED

Effective June 30, 2014, the annual maintenance fee for mining claims increased from \$140 to \$155 per claim for lode mining claims, mill sites or tunnel sites; and from \$140 to \$155 for each 20 acres or portion thereof for each placer mining claim.

The increased maintenance fee will be required for the 2015 assessment year and is due on or before September 1, 2014.

If you have already paid your 2015 maintenance fee payment, you must send in the additional \$15 per claim, prior to September 1, 2014. (Placer mining claims over 20 acres must send in an additional \$15 per 20 acres or portion thereof.)

Also, the location fee for new mining claims has increased from \$34 to \$37. For new mining claims located on or after September 1, 2014, the cost will be \$212 per mining claim, plus \$155 per additional 20 acres or portion thereof for pricer mining claims. This includes a \$37 location fee, \$155 maintenance fee and \$20 processing fee.

All other mining claim fees will remain the same at this time.



If you have already paid your 2010 maintenance fee payment, you must send in the additional \$15 per claim prior to September 1, 2009.

Also, the location fee for new mining claims has increased from \$30 to \$34. Any new mining claims located on or after September 1, 2009, will cost \$189 per claim. This includes a \$34 location fee, \$140 maintenance fee, and \$15 processing fee.

This change in mining claim fees is in accordance with 30 U.S.C. 28j(c), which authorizes adjustments to the location and annual maintenance fees "to reflect changes in the Consumer Price Index published by the Bureau of Labor Statistics of the Department of Labor every 5 years after August 10, 1993, or more frequently if the Secretary determines an adjustment to be reasonable." The BLM has not adjusted the location and maintenance fees since 2004.

The fee adjustment is published in the Federal Register dated June 29, 2009. Copies of the rule are available from BLM State Offices and its Washington, D.C., Office. The text is also accessible on the Federal Register Web site (<u>www.access.gpo.gov</u>) and is available for public viewing at the Office of the Federal Register.

# IMPORTANT NOTICE!

### INCREASE IN ANNUAL MAINTENANCE FEES AND MINING CLAIM LOCATIONS FEES HAS BEEN RESTORED

- The annual maintenance fees for mining claims, due to BLM on or before September 1, 2005, have increased from \$100 to \$125 per claim.
- The location fee for new mining claims has also increased from \$25 to \$30. Any new mining claims recorded with the BLM on or after June 30, 2005, will cost \$165 per claim. This includes a \$30 location fee, \$125 maintenance fee, and \$10 service charge.
- On July 1, 2004, the Department of the Interior adjusted the location and maintenance fees for mining claims and sites based upon the consumer Price Index (CPI), as required by the Mining Law. See 69 FR 40, 294.
- The Interior and Related Agencies Appropriations Act for fiscal year 2005, Division E, Title I, Section 120 of Public Law 108-447 of December 8, 2004, directed the Department of the Interior to roll back these location and maintenance fees for mining claims and sites to their pre-July 2004 levels. However, the Appropriations Act also provided that the fees would return to their formerly increased levels when BLM had met certain conditions.
- These conditions have now been met and the fees have returned to the levels that are reflected in the regulations found at 43 CFR 3830.21. See 70 FR 38192 dated July 1, 2005.

The current assessment year began 12 noon September 1 2004, and ends 12 noon September 1, 2005.

Every year you must file either a **Claim Maintenance Fee** or a **Maintenance Fee Waiver Certificate** (Waiver).




