Hi Mr Ebert: Thank you for returning my call today and for your assistance in clearing up some issues regarding these claims. I understand that the Downstream No 1 Claim has incorrectly included this approx 5 acres of State Land in the northeast quadrant of that claim for some time, but that it was just now "adjudicated" or in other words verified and discovered by BLM when the most recent transfer was made to Auza Ranches. Apparently, the claim had just not been "adjudicated" before that for some reason. Since we can't make a claim on State Land, I understand that there is really nothing we can do, or should do in regard to that Claim. It just is what it is and it's about 15 acres effectively instead of the 20 acres shown on the notice of location.

As for the Downstream No 6 claim, I understand we will be getting a notice (letter) on that claim too, stating that the federal highway may bisect the north east corner of the claim and that federal law prohibits location of a mining claim on two sides of a "federal aid highway ". Accordingly, I understand we have a couple of options on this claim. We can go to the District BLM office and check the " right of way case" to make sure the highway transects the claim or we can go to the claim and simply see if the NE corner is on the other side of the Highway. If its not, then we can write a letter in response stating that no part of the claim is bisected by the highway. Or, if the highway does bisect the claim, then we need to file an Amended Notice of Location , which we can do on a copy of the existing location notice by marking it "Amended" and adding a narrative statement that the Claimant is electing to delete that portion of the claim which is situated on the East side of the highway ( because obviously that is the smaller part). We need to file that amended notice with the county recorder and mail you a copy conformed by the Recorders office before the 30 days expires as stated in the forthcoming letter. That will take care of any issue on the Downstream No 6. Right? Thanks for your excellent job in walking me through these issues. I appreciate you help. Please let me know if I have misunderstood any portion of the above. Regards,

It was a pleasure discussing with you your department's letter of July 29<sup>th</sup>, 2010 which explained the Department's determination that a portion of the land within AMC #380043 is not open to location because it is described as being on land owned by the State of Arizona.

Based upon the maps which you included, it appears that approximately the northeast 5 acres of the 20 acre claim is located on State land. I understand that there have been no changes to the claim and that there have been no amendments to the Notice of Location of Claim and that while the notice of claim includes a portion on State land, this was simply not noticed by the Bureau of Land Management prior to it apparently having obtained a better mapping system. You have advised and I have agreed this determination based upon the portion of the land being located on the State of Arizona land "is what it is". We are obviously not going to change the fact that a portion of the land is owned by the State of Arizona. This will confirm that only the portion of the claim located on the property owned by the State of Arizona is null and void but that the remaining claim remains valid and unaffected.

Pursuant to our recent telephone conversations, I am responding on behalf of my client Auza Ranches L.L.C. to Mr. Hansen's letter of August 20, 2010.

Mr. Hansen's letter indicates that the above referenced claim (AMC 380044) overlaps a Federal Aid Highway right-of-way. My research indicates that the claim appears to protrude into the highway right-of-way for Highway 69 by approximately 100 feet in what would be the northeast corner of the claim.

The purpose of this letter is to advise you that the claimant Auza Ranches L.L.C. hereby abandons any portion of the above referenced claim which overlaps the Federal Aid Highway right-ofway or extends on what would be the northerly side of the right-of-way.
