## Mining Claims Declared Null and Void Ab Initio

Pursuant to Title 43 Code of Federal Regulations (CFR) 3832.1, this office received your notices of location for recordation of mining claims. An insufficient amount of money was received with the claims. Therefore, the claims listed above are declared null and void ab initio.

The location dates on the claims are prior to September 1, 2009, which means they were located in the 2009 assessment year. Therefore, in accordance with 43 CFR 3830.21, \$170 per claim was due at the time of recording (\$15 service fee, \$30 location fee, and \$125 maintenance fee for the 2009 assessment year). However, because you did not record the claims until after September 1, 2009, the 2010 assessment year fee of \$140 was also due at the time of recordation (a total of \$310 per claim). In accordance with 43 CFR 3830.25 and 3830.91, the fees must be paid in full at the time you record a new mining claim, or the claim will be forfeited. Therefore, after subtracting the \$15 per claim non-refundable processing fee for each claim, the remaining funds were applied to as many claims as possible, and those claims are in good standing. However, there was not enough money to pay the fees for the claims listed above. Therefore, the claims listed above are declared null and void and will be closed. A refund will be issued for any remaining money.

This decision may be appealed to the Interior Board of Land Appeals, Office of the Secretary, in accordance with the regulations contained in 43 CFR, Part 4, and the enclosed Form 1842-1. If an appeal is taken, your notice of appeal must be filed in this office (at the above address) within 30 days from receipt of this decision. The appellant has the burden omewing that the decision appealed from is in error.

If you wish to file a petition pursuant to regulation 43 CFR 4.21 (58 FR 4939, January 19, 1993), for a stay of the effectiveness of this decision during the time that your appeal is being reviewed by the Board, the petition for a stay must accompany your notice of appeal. A petition for a stay is required to show sufficient justification based on the standards listed below. Copies of the notice of appeal and petition for a stay must also be submitted to each party named in this decision and to the Interior Board of Land Appeals and to the appropriate Office of the Solicitor (see 43 CFR 4.413) at the same time the original documents are filed with this office. If you request a stay, you have the burden of proof to demonstrate that a stay should be granted.

#### Standards for Obtaining a Stay

Except as otherwise provided by law or other pertinent regulation, a petition for a stay of a decision pending appeal shall show sufficient justification based on the following standards:

(1) The relative harm to the parties if the stay is granted or denied,

(2) The likelihood of the appellant's success on the merits,

(3) The likelihood of immediate and irreparable harm if the stay is not granted, and

(4) Whether the public interest favors granting the stay.
