

It is requested that the Land Office records be noted to the effect that the following described lands are hereby classified as unsuitable for disposal under the public land laws due to the fact that they have been determined to be contaminated by high explosives. These lands were used during World War 2 in connection with the maneuvers by units under the command of General Patton and it has been determined that the lands are so contaminated that clearance is impracticable, and no use of these lands should be permitted which would require disturbance of the surface.

The District Managers are being advised to note their records in order that the grazing permittees may beware of the contaminated nature of the lands.










Wenden King Location Map Lode Claim

It is requested that the Land Office records be noted to the effect that the following described lands are hereby classified as unsuitable for disposal under the public land laws due to the fact that they have been determined to be contaminated by high explosives. These lands were used during World War 2 in connection with the maneuvers by units under the command of General Patton and it has been determined that the lands are so contaminated that clearance is impracticable, and no use of these lands should be permitted which would require disturbance of the surface.

The District Managers are being advised to note their records in order that the grazing permittees may beware of the contaminated nature of the lands.


