

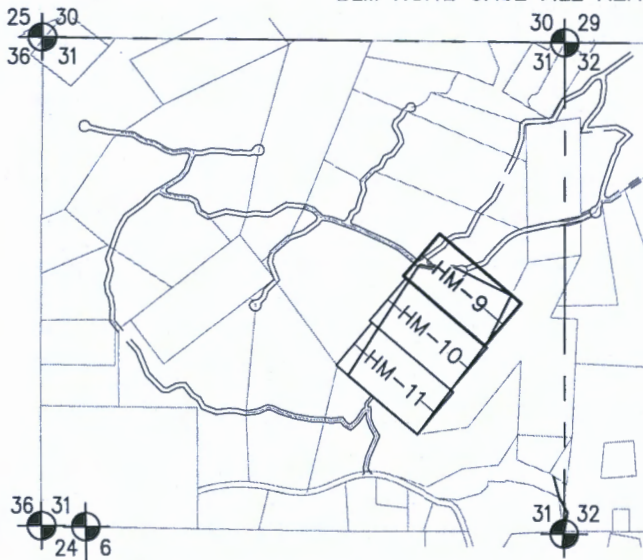

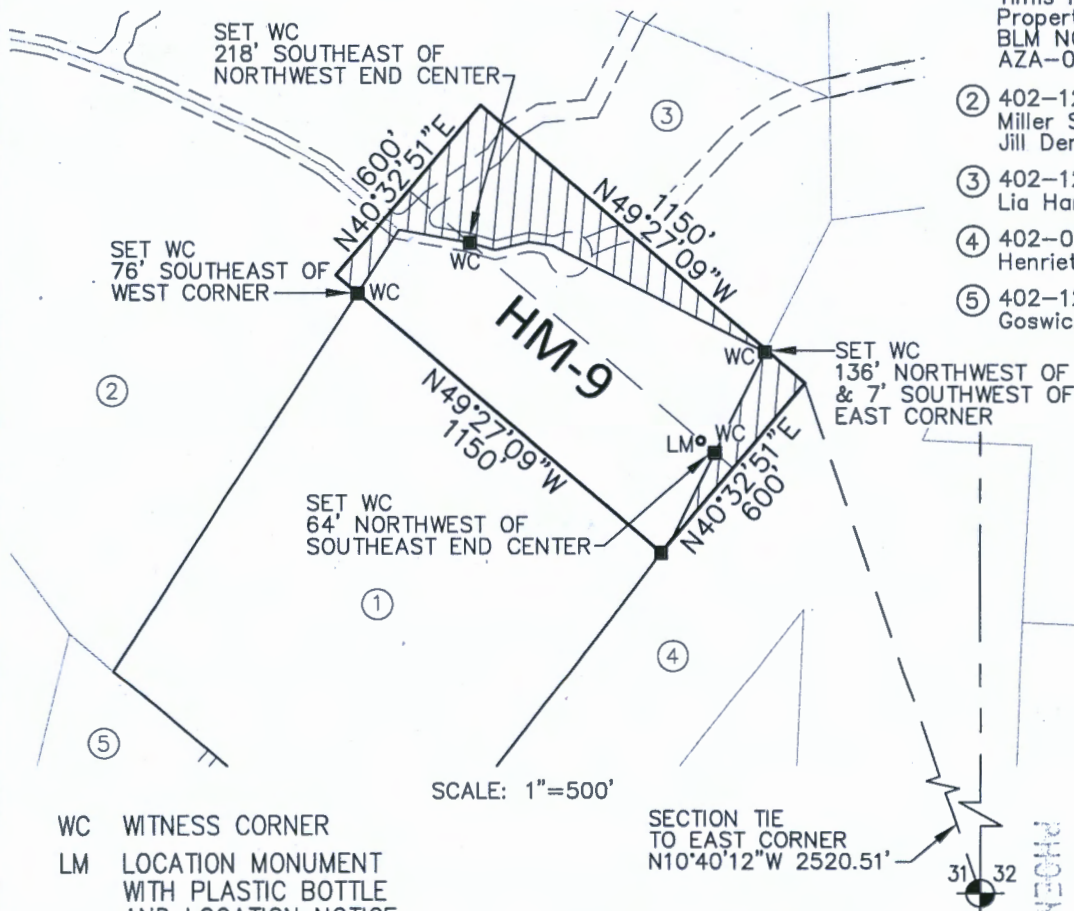


TOWNSHIP 13 NORTH, RANGE 1 EAST

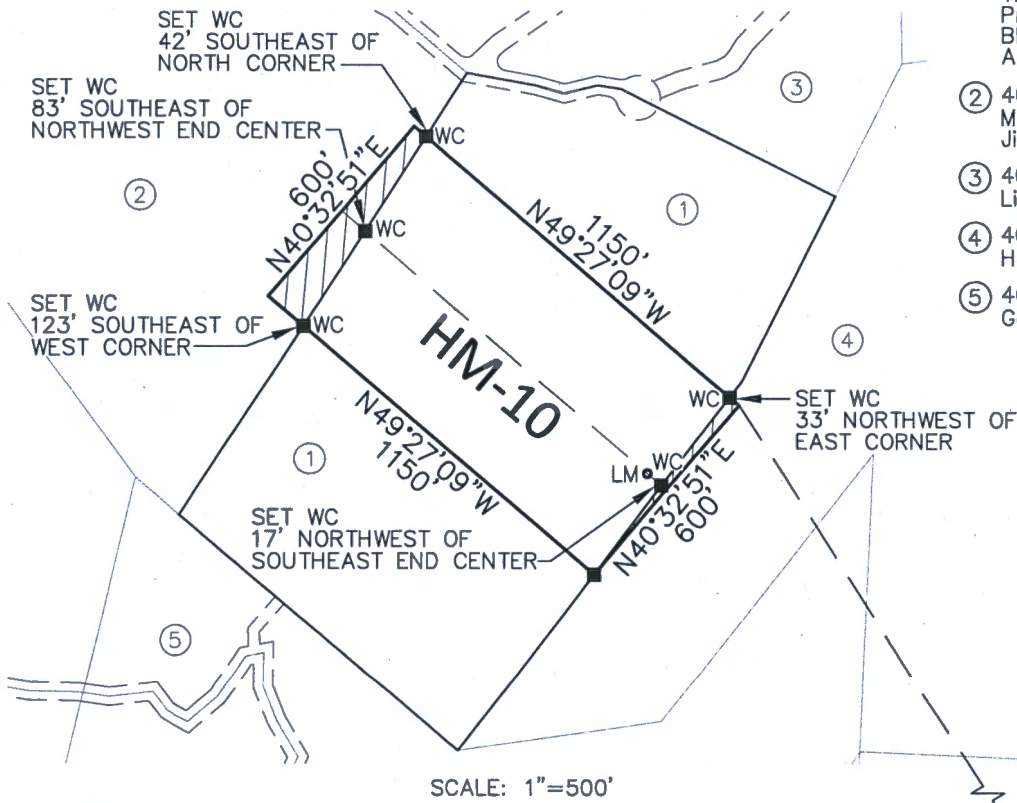

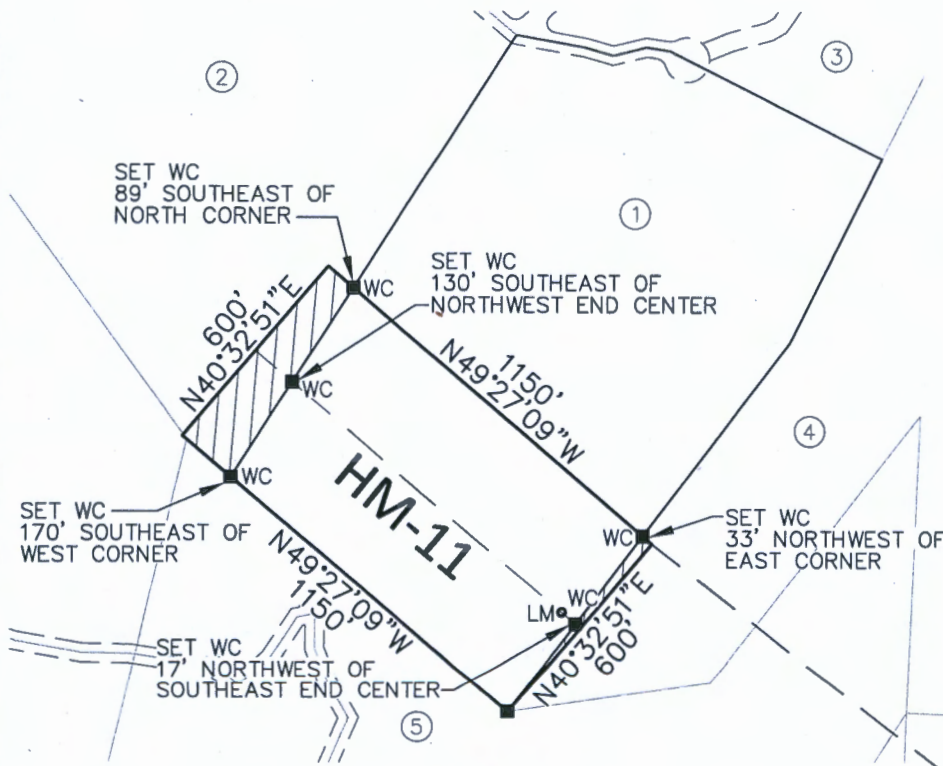
