### MINING CLAIM(S) DECLARED FORFEITED

The mining claim listed above has/have been declared forfeited as of September 1, 2020, for failure to timely file the required maintenance fee payment or small miner's maintenance fee waiver (waiver).

Claimants are required to pay an annual non-refundable maintenance fee of \$165 per 20 acres or portion thereof, or submit a waiver, on or before September 1 of each year. These requirements were established by 30 U.S.C. 28f-l, as amended, and 43 Code of Federal Regulations (CFR) 3834 and 3835.

Our records show receipt of a maintenance fee payment on August 5, 2020; however, the payment was insufficient to cover the claims listed. An additional \$10 was received on September 3, 2020, two days, after the due date of September 1, 2020. Therefore, the claim listed above is forfeited.

- (1) The relative harm to the parties if the stay is granted or denied,
- (2) The likelihood of the appellant's success on the merits,
- The likelihood of immediate and irreparable harm if the stay is not granted, and
- (4) Whether the public interest favors granting the stay.



#### Amendment Not Processed

An amendment for AMC62870 was received by the Bureau of Land Management (BLM), Arizona State Office. The amendment cannot be processed for the following reason:

You cannot amend a mining claim to increase the acres in the claim.

The BLM recently entered the acreage of all mining claims into our computerized records. The acreage of your claim was erroneously entered as 100 acres. Due to the change in the maintenance fee calculations for placer claim over 20 acres, the BLM sent you a letter, dated October 31, 2012, requesting additional maintenance fees or an amendment to reduce the acres in the claim. You responded by paying an additional \$140 maintenance fee and filing an amendment describing your claim as being 40 acres in size and located in the SWSW of Section 26, T. 18 N., R. 3 E.

Upon review of the documents in the claim case file it was noted that your claim is actually only 20 acres in size. Our records have been corrected and therefore, no additional maintenance fees are due and no amendment is required to reduce the claim acres. The \$150 submitted with the amendment on November 28, 2012, will be refunded

The original location notice shows that the claim was 100 acres when originally located March 15, 1947, however, the claim was transferred to Charles E. Abel by Quit Claim Deed (QCD) dated April 17, 1979. The QCD very clearly states that only 20 acres was transferred.

Mr. Abel filed this 20-acre claim with the BLM on September 13, 1979, as was required by the Federal Land Policy and Management Act. This 20-acre claim was then transferred from Mr. Abel to Charles E. Dippold and John M. Dippold by QCD dated July 15, 1980. The dimensions of the claim, as described in both QCD's are 933.3 feet by 933.3 feet, which equates to 19.99 acres.

Also, please note that the amendment filed erroneously describes the claim in the SWSW of Section 26, T. 18 N., R. 3 E. The map filed with the amendment has the section numbers for Section 25 and Section 26 reversed. Therefore, the claim would actually be in the SENE and the NESE of Section 26 and possibly in the SWNW and the NWSW of Section 25. The map filed by Mr. Abel on September 13, 1979, clearly depicts the claim in the SE and NE quarters of T. 18 N, R. 3 E. Section 26. This same map was filed by the Dippold's on September 15, 1980, along with their QCD, confirming their acknowledgement of the location of the claim. Copies of the two QCD's and the maps are enclosed.


