ORDER

Elijah Wencl appealed a December 17, 2019, decision issued by the Deputy State Director, Division of Lands, Minerals, and Energy, Arizona State Office, Bureau of Land Management (BLM). In the decision, the Deputy State Director declared the Gold Treasure II and Goldenhawk 5 association placer mining claims (AMC-395797 and AMC-400507) forfeited for failure to pay annual maintenance fees for the 2020 assessment year.

SUMMARY

A person holding an unpatented mining claim must pay a maintenance fee for the claim by September 1 of each year. If the claimant fails to do so, the claim is forfeited by operation of law. Here, the record shows that although Mr. Wencl timely submitted payment for his claims, the bank did not honor his check because the account on which the check was drawn was closed. In that situation, BLM properly determined that the maintenance fees were not paid and declared the claims forfeited. We therefore affirm BLM's decision.

BACKGROUND

A. The Requirement to Timely Pay Annual Maintenance Fees

Under applicable law, a person who holds an unpatented mining claim must pay a yearly maintenance fee on or before September 1 of each assessment year.¹ The

"assessment year" is the twelve-month period beginning at noon on September 1 each year.² A claimant who does not pay a maintenance fee by the deadline automatically forfeits the mining claim as a matter of law.³ Although a mining claimant may qualify for a waiver of annual maintenance fees under certain conditions, no waivers are at issue in this appeal.⁴

B. BLM's Decision

Here, Mr. Wencl was required to pay maintenance fees for his two association placer mining claims by September 3, 2019, for the 2020 assessment year.⁵ In its decision, BLM declared the claims forfeited for failure to pay these fees by the deadline.⁶ BLM stated in its decision that although it received a check from Mr. Wencl paying the fees for his claims before the deadline, "the check/credit card was not honored by your bank and was returned to us for insufficient funds."⁷ BLM explained that under the applicable regulations, when a bank does not honor payment, this "is considered to be a nonpayment of the charges or fees."⁸ It therefore declared the two claims forfeited by operation of law.

DISCUSSION

On appeal, Mr. Wencl has the burden to show that BLM erred in declaring the claims forfeited.⁹ He has not met that burden.

The record shows that BLM received Mr. Wencl's check paying a total of \$1980 in fees for his two claims on August 27, 2019.¹⁰ The record also shows that the account on which the check was drawn was "closed."¹¹

Under BLM's regulations and Board precedent, a mining claimant will be deemed to have failed to comply with the requirement to pay maintenance fees when the payment is properly dishonored by the bank.¹² In his appeal, Mr. Wencl acknowledges that his check was "bad," and that the reason the bank did not honor his check was that his "accounts were all closed due to identity theft attempt."¹³ He states that after he closed his bank accounts he mistakenly used a check from a closed account to pay the maintenance fees for his claims.¹⁴

Because Mr. Wencl's payment was properly not honored by his bank, BLM properly determined that the payment had not been made and declared the claims forfeited by operation of law. While Mr. Wencl's situation is unfortunate, neither this Board nor BLM is authorized to excuse a mining claimant's lack of compliance with the maintenance fee requirement, extend the time for compliance, or afford any relief from the automatic claim forfeiture provisions in the law.¹⁵

Mr. Wencl may relocate the claims if there are no intervening rights and the land remains open to mineral location.

CONCLUSION

Because Mr. Wencl did not pay the required maintenance fees for his claims for the 2020 assessment year by the deadline, his claims were automatically forfeited. Accordingly, pursuant to the authority delegated to the Board of Land Appeals by the Secretary of the Interior,¹⁶ we affirm BLM's December 17, 2019, decision.

Your maintenance fee payment for the 2013 assessment year, in the amount of \$140 per claim, for the placer claims listed above, has been received and is insufficient. The total due on your claim(s) is: \$1400.

The purpose of this letter is to remind you that you must be qualified to locate an association placer mining claim and that your mining claim must conform to the requirements of Federal law, 30 U.S.C. §§ 35, 36, and regulations 43 CFR 3832.22. These laws allow the location of mining claims greater than 20 acres so long as each of the locators has a bona fide interest in the claims, and has located the claims independently, for their own self-interest, and in good faith.

The law is well established that a person cannot use the names of his friends, relatives, or employees as dummy locators in order to locate for his own benefit a greater area of placer ground than is allowable by law. A claim located using dummy locators is not a valid mining claim.
