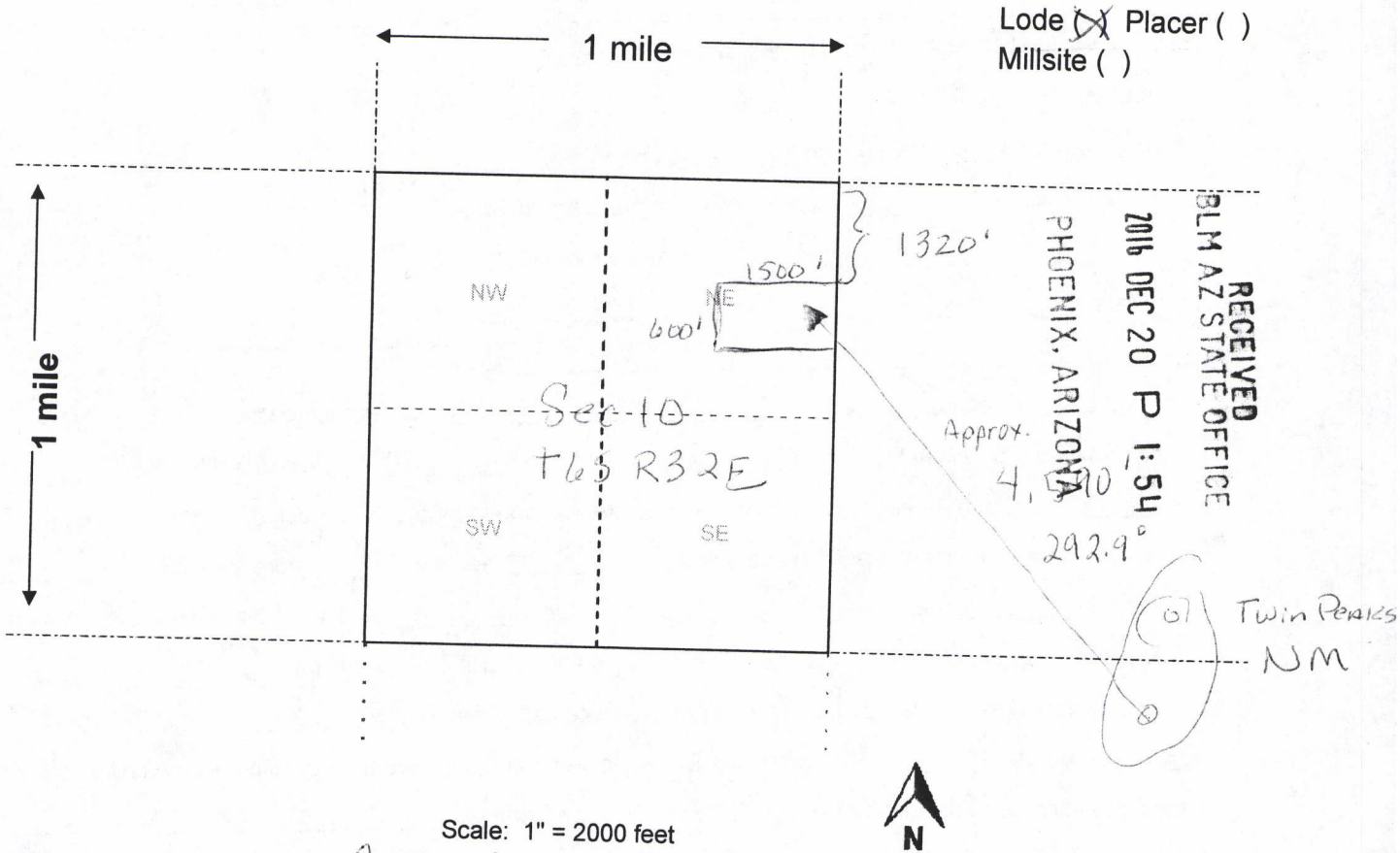

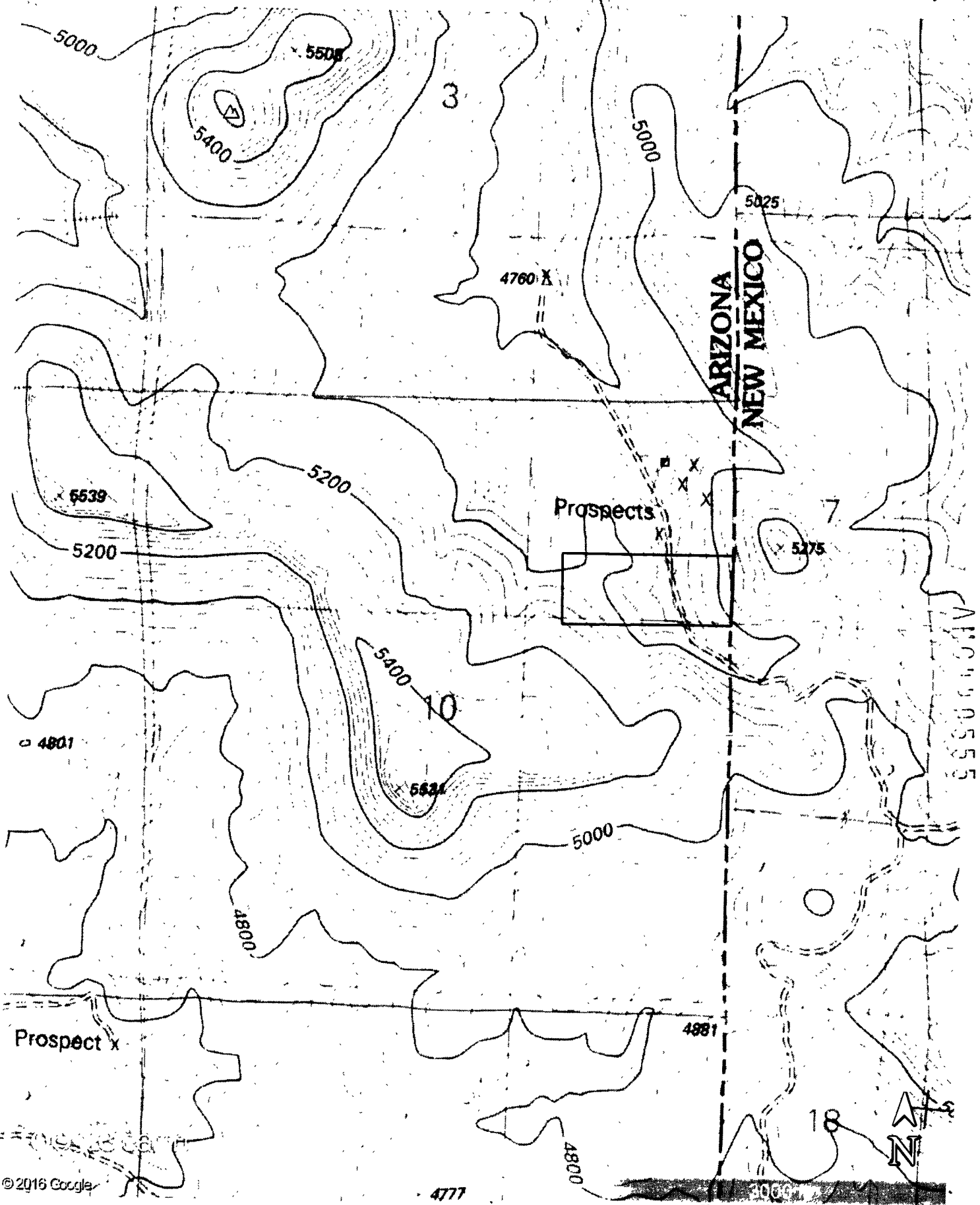


Copper Basin Claim
