

CalPortland Co has received a Notice dated 7/31/18 from the BLM Arizona State Office for the placer mining claims below:

AMC445815, AMC445816, AMC445817, AMC445818, AMC445819, AMC445820, AMC445821, AMC445822. (Liberty 1-8)

The notice suggests that our Liberty 1-8 placer claims have an inadequate legal description because they have been described by metes and bounds. In fact, all of our Liberty 1-8 placer claims had to be staked by metes and bounds outside of standard legal subdivision because they were bounded by both other mining claims and nonmineral private lands. In order to fit within available land, remain contiguous, overlay respective lode claims, and to follow the public land survey system "as much as possible" as specified by 43 CFR 3832.12, the claims were staked, located, and submitted with a metes and bounds legal description, as well as an aliquot parts description down to quarter section, and were included with maps tying one claim corner per claim to the SW section corner monument. According to 43 CFR 3832.12(c)(iii) we are within our rights to have staked the Liberty 1-8 claims outside of standard legal subdivision in our situation as we have.

The attached map illustrates and proves the necessity of staking our claims outside of standard public land survey system subdivisions beyond quarter sections. Also attached are printed photos of the CW claim group maps and location notices which are in the same section (pre-existing from another company or person), as well as a plat map of the section showing private land holdings, and lastly a copy of the BLM letter Received.



MAP OF LIBERTY Claim Group PLACER MINING CLAIMS IN SECTION 20, T.16.5.N, R.18.W, G&SRB&M




