To all to whom these presents shall come, Greeting:

WHEREAS, under the provisions of Section 8 of the Act of June 28, 1934 (48 Stat. 1269), entitled "An Act To stop injury to the pub-lic grazing lands by preventing overgrazing and soil deterioration, to provide for their orderly use, improvement, and development, to stabilize the livestock industry dependent upon the public range, and for other pur-poses," as emended by Section 3 of the Act of June 26, 1936 (49 Stat. 1976), the State of Arizona, in exchange for certain other lands situated in said State, has selected the following described tract of land:

The west helf of the east half and the west half of Section four-teen, the Sections twenty-two, twenty-three, twenty-four, twenty-five, twenty-six, twenty-seven, and thirty-four, and the northwest quarter of Section thirty-five in Township seven north of Range five west of the Gila and Selt River Meridian, Arizona, containing five thousand one hundred twenty acres, according to the Official Plat of the Survey of the said Land, on file in the General Land Office:

NOW KNOW YE, That the UNITED STATES OF AMERICA, in consideration of the premises, and in conformity with the said Acts of Congress, HAS GIVEN AND GRANTED, and by these presents DOES GIVE AND GRANT, unto the said State of Arizona, in fee simple, the tract of land above described; TO HAVE AND TO HOLD the same, together with all the rights, privileges, immun-ities, and appurtenances, of whatsoever nature thereunto belonging, unto the said State of Arizona, and to its assigns forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts; and there is reserved from the lands hereby granted, a right of way thereon for ditches or canals con-structed by the authority of the United States. Reserving, also, to the United States, all minerals in the lands so granted, together with the right to prospect for, mine and remove the same, as authorized by the pro-visions of said section 8, as emended as aforesaid.
