#### Mining Claims Declared Null and Void

Pursuant to Title 43 Code of Federal Regulations (CFR) 3832.1, this office received your notice of location for recording mining claims. In accordance with 43 CFR 3833.91 and the 43 CFR Part 3838, the mining claims listed above are hereby declared null and void ab initio for the reasons indicated below.

The land included in these 18 mining claims is in T. 5 S., R. 5 E., sec. 33 NW1/4 and NE1/4, which was patented under the Stock Raising Homestead Act of December 29, 1916 (43 U.S.C. 299), as amended by Public Law 103-23, April 16, 1993), Patent #1004241.

On October 28, 2019 a properly completed Notice of Intent to Locate (NOITL) mining claims under the Stock Raising Homestead Act of 1916, (43 U.S.C. 299, as amended by Public Law 103-23, April 16, 1993) (the Act), was received by the Bureau of Land Management (BLM) Arizona State Office, from Cactus 110 LLC. The land included in this NOITL is T. 5 S., R. 5 E., sec. 33 NW1/4 and NE1/4. When a properly completed NOITL is received by BLM, it begins a 90-day segregation period for the land included in the NOITL. During this 90-day period no other person, including the surface owner, may submit a NOITL or locate mining claims on these

lands. The 90-day segregation period for this NOITL began on October 29, 2019 and ended on January 27, 2020.

On December 11, 2019 Arcus Copper Mountain Holdings, LLC; Arcus Forever 7, LLC; East Pioneer-Arcus Copper Mountain, LLC; and Arcus & Arete Capital Investments, LLC, c/o Arcus Private Capital Solutions, located the above listed mining claims within the 90-day segregation period of the NOITL filed on October 28, 2019 by Cactus 110 LLC. Although these companies are the surface owners for the lands in question, no other person including the surface owner can locate mining claims on land included in a NOITL that is within the 90-day segregation period. Therefore, these 18 mining claims are declared Null and Void.

This decision does not relieve you of the liability for reclamation of all areas disturbed by your activities on land encompassed by your mining claim and/or site. After you complete the reclamation, you must notify the authorized officer of the appropriate surface managing agency so that the authorized officer may conduct a final site inspection and determine whether you may be released from liability. If you fail to reclaim the land to the satisfaction of the authorized officer, the surface management agency may cite you for noncompliance under its surface management regulations.

For land administered by the Bureau of Land Management (BLM), if you fail to reclaim the land to the satisfaction of the authorized officer as required in 43 CFR Subpart 3809, the BLM will issue an order of noncompliance under 43 CFR 3809.601(a). If you fail to comply with the noncompliance order, the BLM may take further action under 43 CFR 3809.604. Failure to conduct reclamation is a prohibited act that may subject you to criminal penalties. See 43 CFR 3809.605(h) and 43 CFR 3809.700. If your occupancy has been terminated and you fail to remove structures, material, and equipment, and any personal property in accordance with the regulations in 43 CFR 3715.5-1, the BLM may dispose of the property. In accordance with 43 CFR 3715.5-2, you will remain liable for the costs the BLM incurs in removing and disposing of the property.

#### **Appeal Procedures**

This decision may be appealed to the Interior Board of Land Appeals, Office of the Secretary, in accordance with the regulations contained in 43 CFR, Part 4 and the enclosed Form 1842-1. If an appeal is taken, your notice of appeal must be filed in this office (at the above address) within 30 days from receipt of this decision. The appellant has the burden of showing that the decision appealed from is in error.

If you wish to file a petition pursuant to regulation 43 CFR 4.21 (58 FR 4939, January 19, 1993), for a stay of the effectiveness of this decision during the time that your appeal is being reviewed by the Board, the petition for a stay must accompany your notice of appeal. A petition for a stay is required to show sufficient justification based on the standards listed below. Copies of the notice of appeal and petition for a stay must also be submitted to each party named in this decision and to the Interior Board of Land Appeals and to the appropriate Office of the Solicitor (see 43 CFR 4.413) at the same time the original documents are filed with this office. If you request a stay, you have the burden of proof to demonstrate that a stay should be granted.

#### Standards for Obtaining a Stay

Except as otherwise provided by law or other pertinent regulation, a petition for a stay of a decision pending appeal shall show sufficient justification based on the following standards:

- (1) The relative harm to the parties if the stay is granted or denied,
- (2) The likelihood of the appellant's success on the merits,
- (3) The likelihood of immediate and irreparable harm if the stay is not granted, and
- (4) Whether the public interest favors granting the stay.
