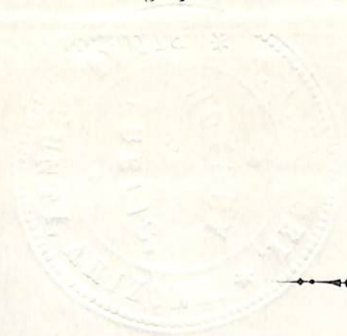

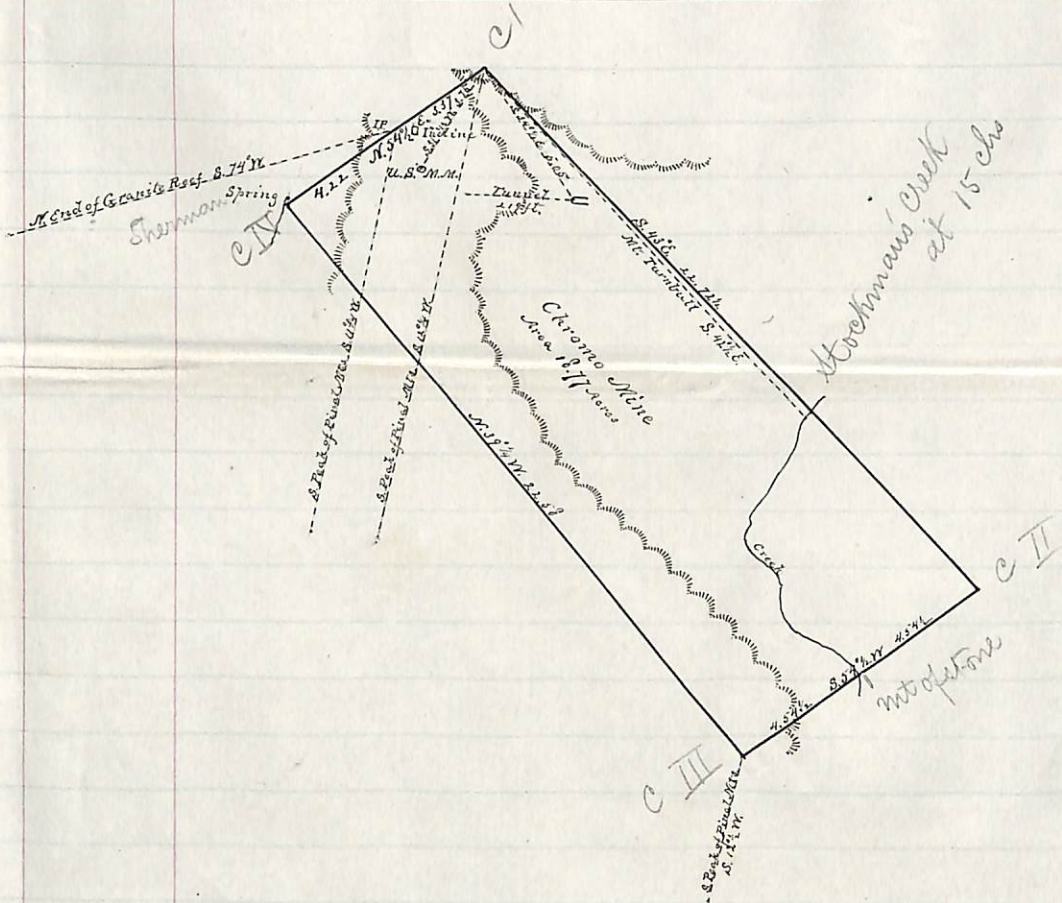

Field Notes of the Chromo Mine
Surveyed Dec. 12th 1878

Beginning at the Initial Point which is marked by a monument consisting of a round Cedar Post 4 inches in diameter 3 feet high surrounded by a mound of stones set on the dump of the Incline and is on the West slope of the Chromo hill about two thirds of the way up.

Thence N. $54\frac{1}{2}^{\circ}$ E. 3.37 chains to a monument of stones three feet high situated near the head of a ravine which runs in a S. Easterly direction marked C. I. and being the North corner of the claim.

Thence S. 43° E. 22.72 $\frac{1}{2}$ chains down the ravine crossing Stockman's Creek at 15 chains to a monument of stones three feet high marked C. II. situated on the East side of a small gulch being the East cor. of the claim.

Thence S. $54\frac{1}{2}^{\circ}$ W. 4.54 $\frac{1}{2}$ chains to a monument of stones three feet high not marked situated in Stockman's Gulch on the East side of the creek.

Thence S. $54\frac{1}{2}^{\circ}$ W. 4.54 $\frac{1}{2}$ chains up a steep hill to a monument of stones three feet high marked C. III. being the South corner of the claim.

Thence N. $39\frac{1}{4}^{\circ}$ W. 22.58 over the hill to a monument of stones three feet high marked C. IV. situated in the bottom of the Sherman Gulch 15 links S. $10\frac{1}{2}^{\circ}$ W

from the Sherman spring, being the West corner of the claim.

Thence N. $54\frac{1}{2}^{\circ}$ E. 4.22 chains to the place of beginning.
Area - 18.47 acres.

From the North corner to the U.S. Mineral monument which consists of a mound of stones and ore four feet high on the apex of a round knoll on the Chumo hill and marked U.S. M. M. is S. $31\frac{1}{3}^{\circ}$ W. 3.76 chains.

From the North corner to the mouth of the Tunnel is S. $34\frac{1}{2}^{\circ}$ E. 5.05 chains.

From the North corner the S. Peak of the Pinal Mountains bears S. $12\frac{1}{4}^{\circ}$ W. Mt. Turnbull bears S. $42\frac{1}{4}^{\circ}$ E.

From the Initial Point to the mouth of the Incline is N. $74\frac{1}{2}^{\circ}$ E. 60 links. The South Peak of Pinal Mts. bears S. $11\frac{1}{4}^{\circ}$ W. The North end of a Granite reef bears S. 74° W.

From the South corner to the South Peak of Pinal Mts. S. $12\frac{1}{2}^{\circ}$ W.

From the U.S. Mineral monument to Mt. Turnbull is S. $42\frac{1}{2}^{\circ}$ E. The South Peak of the Pinal Mts. S. 12° W. The North end of Granite reef S. 76° W. Highest mountain towards Mc Miller N. 53° E.

The work consists of a Tunnel running N. 88° W 219 feet long and cost at least \$10.00 per foot making \$2190.00.

A cut at the mouth of the Tunnel $32\frac{1}{2}$ feet long and 12 feet deep at the point where the tunnel begins and cost about \$50.00. An incline shaft $4\frac{1}{2} \times 6$ feet 48 feet deep and cost about \$12.00 per foot making \$576.00 making a total of \$2816.00

The Claim is situated on the South side of the Apache range about 10 miles N. N. E. of Globe and is in a Granite formation.

The variation is $13^{\circ} 20'$ East of North as determined by observation of Polaris.

The lines are all run on true bearings

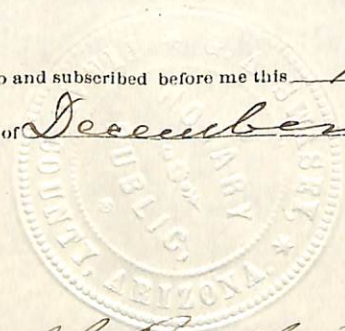

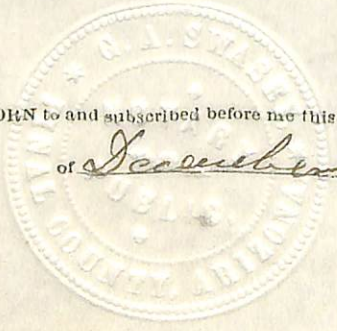


