General Description.

The East Side Mining Claim is situated in the Tombstone Mining District Cochise County Arizona Territory, and north of Lucky Cuss Hill and near the north west end of the Tombstone Hills, and is bounded by the following claims, on the north east by the Tribute Mining Claim on the north west by the Blue Monday and Triangle Mining Claims.
