Location of U. S. Mint Mont. No. 4, Papago District,

In compliance with instructions from the Sur. G. of Arizona, dated Oct 4. 1881, to survey the "Silver Crown" Mining claim, situated in the Papago Mining distr, Sierritas mountains, Pima Co. - and not finding any corner or monument of a U. S. survey - I the undersigned Dep. Mt. Sur. proceed, Oct 6<sup>th</sup> 1881 - to erect a U. S. Mint Monument.

I go on the top of a prominent hill on the "Silver Crown" claim, where I plant a mesquite post, 4 x 4' 8 feet long, one foot in rocky ground, and surround it with a mound of rock, 4 feet high and 5 feet diameter at base, I mark said post: <sup>U. S. M. M.</sup> n. 4. P. D.

From this Monument, variation by Polaris being  $N 12^{\circ} 37' E$ . - I take following bearings:

These consist of

- 3) One crosscut towards ledge from bottom of shaft, 25 ft long, 4 1/2' x 6'.
- 4) One incline shaft on ledge 10' long 4' x 5'.

All of which work I consider to exceed the value of \$500, and I find it to be executed by the applicants and their grantors.

General Description

The 'Silver Crown' Mining claim is located in the Sierritas, a low range of hills in the

Papago Mining Distr, Pima Co., about 30 miles S. W from Tucson and about 2 miles S. W. of Boggs's Mine, northward it joins on to the Bentley n<sup>o</sup>. 2.

The ledge is between talose slate and limestone, and its strike is S 30° East, its dip about 66° N. East.

Its ore is carbonate and sulphide of lead containing silver, and some copper. — the matrix is quartz - several feet wide.

The surrounding hills contain some mesquit timber - water appears scarce but sinking is liable to produce considerable.

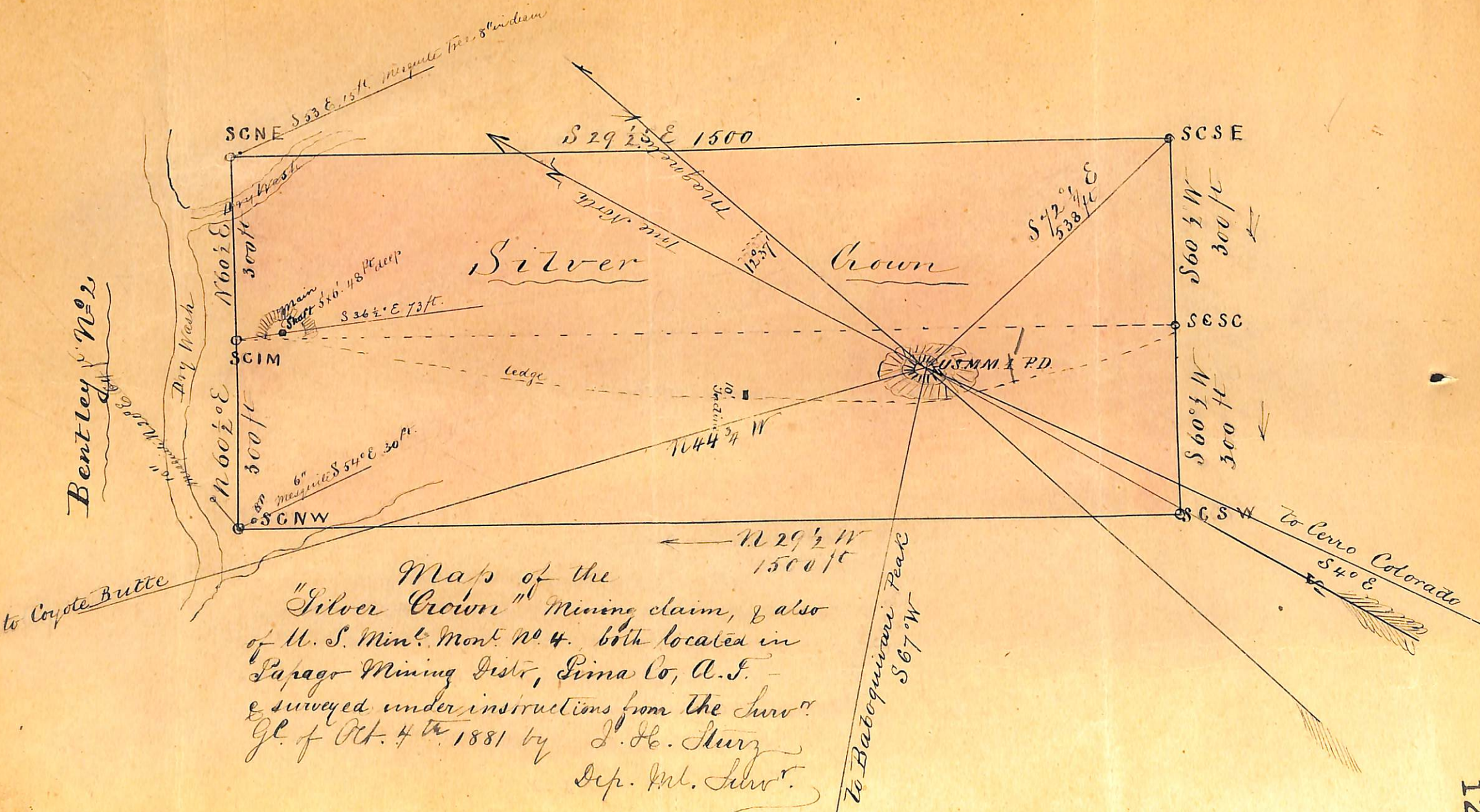
