On a divide 30 feet to right of the trail leading from the well known old Salero House, up to the Mammoth Mine. I set a red wood post 12 feet long, 4 in square firmly in the ground, deposited charcoal, and build around it a monument of stone 6 1/2 feet square at base and 5 feet high. I mark post. U. S. M. M. 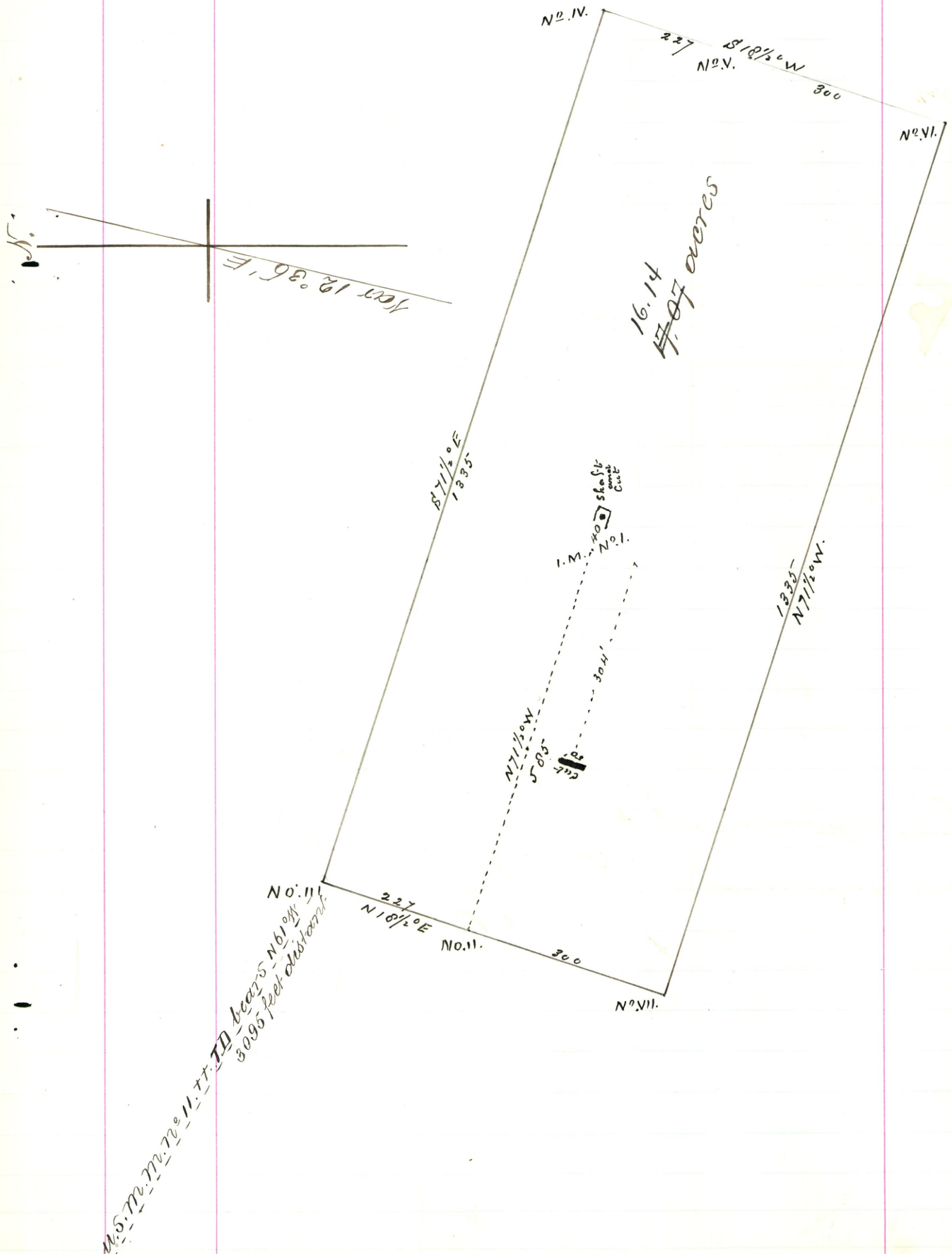
