Notice of Location, Notice is hereby given that in pursuance of an Act of Congress, dated May 10, 1872, We the undersigned have this day located and claimed Fifteen Hundred (1500) ^{linear} feet on this vein or lode of mineral bearing ore and Three hundred (300) feet in width on each side thereof, situated and described as follows to wit; Commencing at a monument of stones on the ledge on the east end of Claim, which bears westerly from "San Xavier Mines" about one half ($\frac{1}{2}$) mile thence North Three Hundred (300) feet to a monument of stones, Thence West (1500) fifteen hundred feet to a monument of stones, thence south to the Centre of Claim to a monument of stones three hundred feet, thence south three hundred feet to a monument of stones, thence East fifteen hundred feet to a monument of stones, thence North three hundred feet to a monument of stones to the place of beginning. 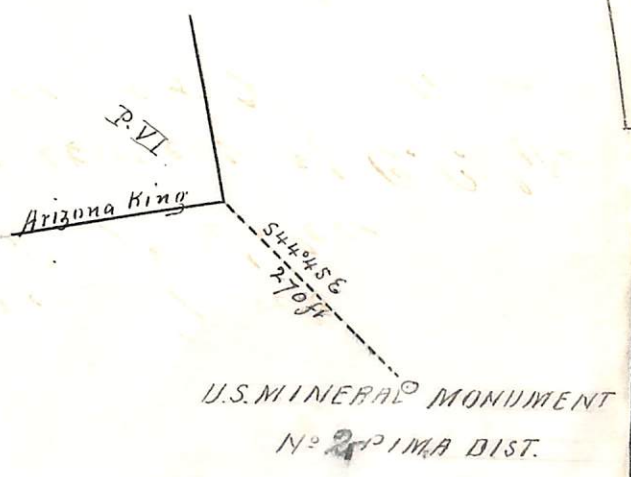
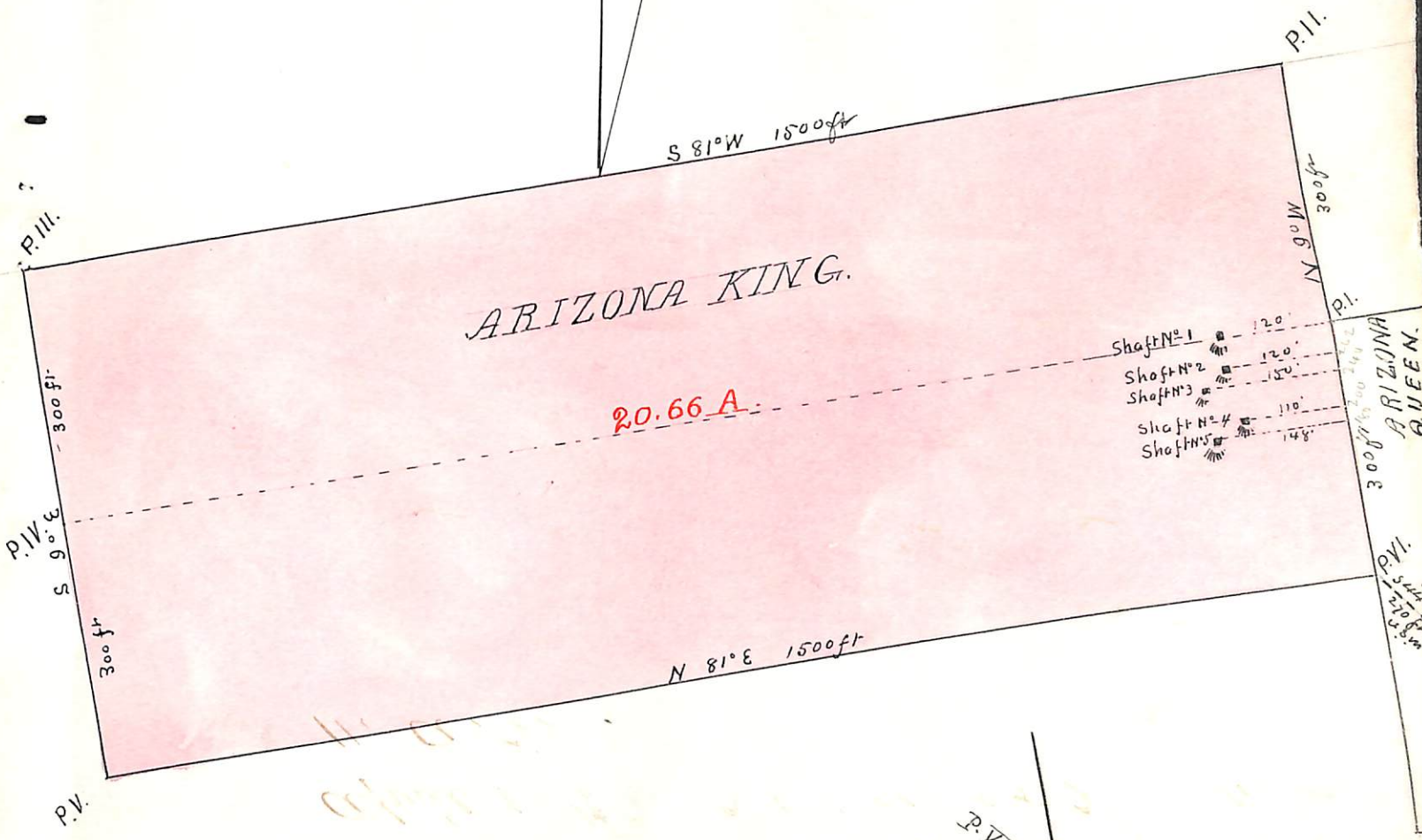
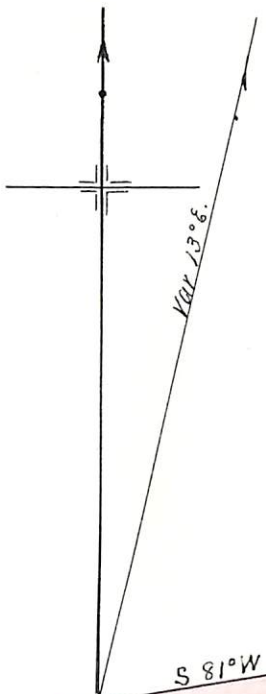
