marked G. D. M. C. No. 6, enclosing a Total area of 15.27 acres out of which 0.03 acres is in conflict with Rattlewake mine which area is claimed by present Applicants, Thus making an area of 15.27 ac the land for which a Patent is asked for.

The above mine is situated about 2 miles South of City of Tombstone on the West Side of Military Hill. There is no Timber or water on Claim. The improvements consist of 1 shaft 250 feet deep, and Crosscut at bottom run West 50 feet, also three open cuts $\&$ being $36 \times 4 \times 3$ feet. $12 \times 2 \times 2$ feet and $12 \times 2 \times 2$ feet. all these cuts are made on the ore vein. There is also a lumber house 22×14 feet. all the above improvements were made by present Applicants and their grantors, and are valued at over $\$3000$.

In the survey of The Emerald Mining Claim The West line had to be contracted in order to comply with the requirements of Law regarding width of surface ground on each side of vein. To accomplish the above I placed post 8 at a distance of 300 feet from initial monument and surveyed the West side line through that point. The south end line also had to be drawn in, in order to make it parallel with north line, and to make survey all within the ground originally located, which has been done in this case
