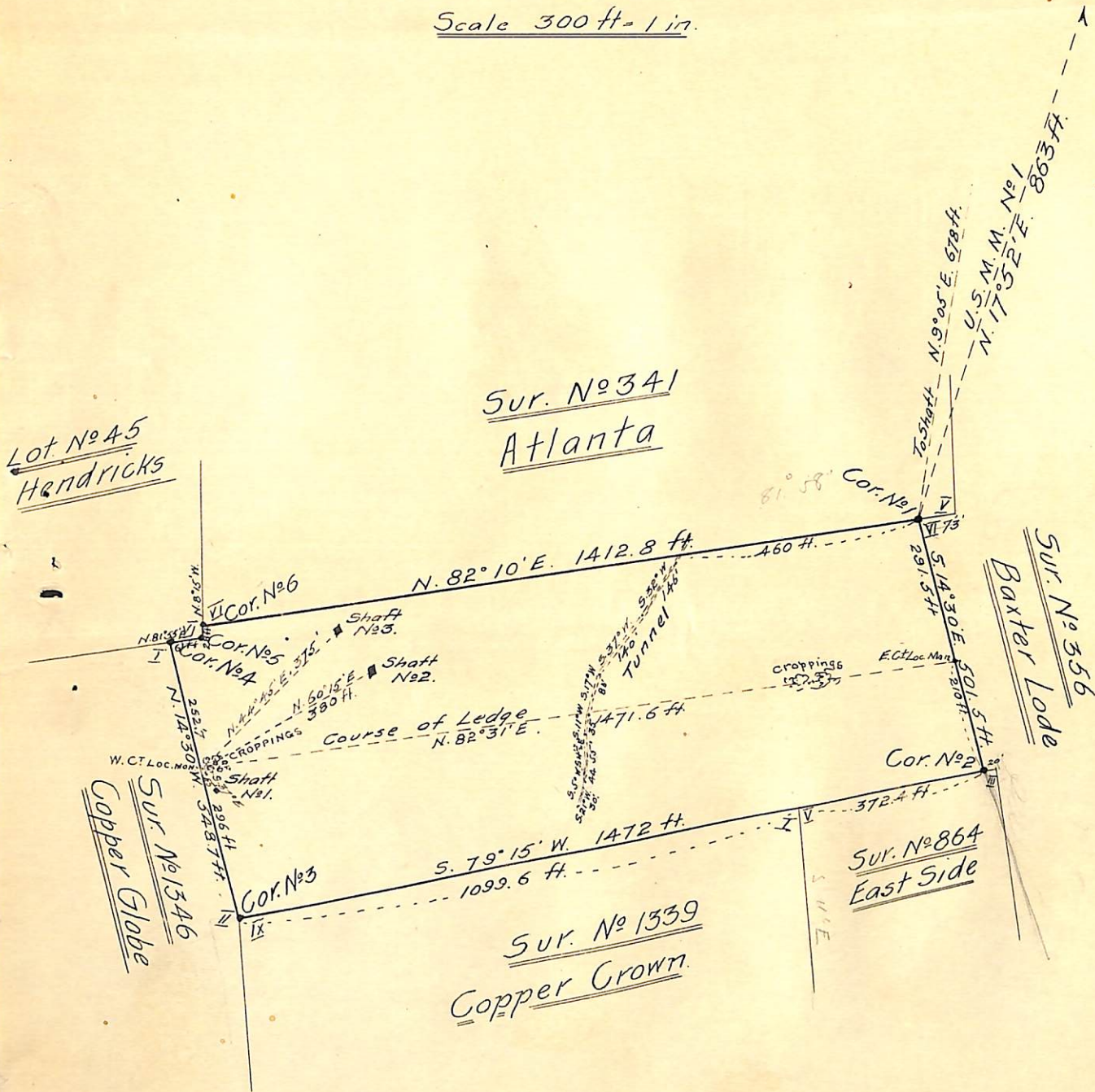


SURVEY No 1348
