Notice of Mining Location.
Lode Claim.

To all whom it may concern: This mining claim, the name of which is the Andrea Mining Claim, situate on lands belonging to the United States of America, and in which there are valuable mineral deposits, was entered upon and located for the purpose of exploration and purchase by Mark Bradley, William Christman & H.M. Rolston, the undersigned, on the 12th day of June, 1903.

The length of this claim is 1500 feet and we claim 750 feet in a northerly direction and 750 feet in a southerly direction from the center of the discovery shaft, at which this notice is posted, lengthwise of the claim, together with three hundred (300) feet in width of the surface grounds, on each side of the center of said vein. The general course of the lode deposit and premises is from the northerly to the southerly.

The claim is situated and located in the Cherry Creek Mining District, in Yavapai County, in the Territory of Arizona, about a mile in a westerly direction from the Sitting Bull Mining Claim, and near the head of the East fork of Cherry Creek.

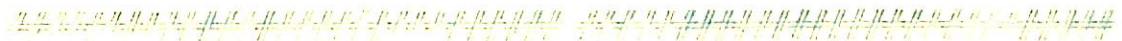
