As this tunnel is 250 ft. below the surface at the Liverpool shaft, it will, if continued in its present course and drifts and cross cuts run therefrom, develop this group of lodes as above stated.

INSTRUMENT.

This survey was made with a Buff & Berger light mountain Transit. The courses were deflected from the true meridian as determined by Polaris observations. The distances were measured with 50 ft. and 500 ft. steel tapes.

The length of this claim is seven hundred feet, and we claim six hundred and seventy five feet in a north 76° 45' east direction, and twenty five feet in a south 76° 45' west direction from the center of the discovery shaft, at which this notice is posted, lengthwise of the claim, together with ten feet in width of the surface grounds, on each side of the center of said claim. 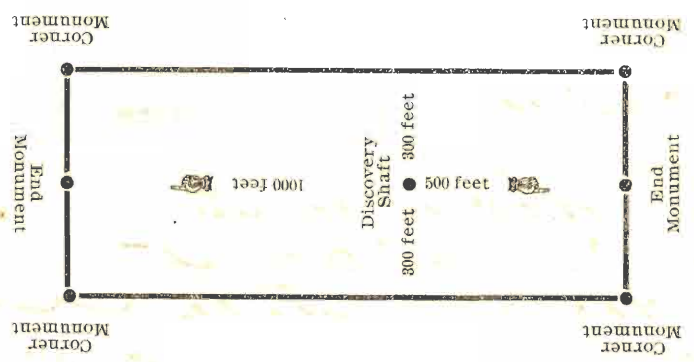
