

An error of 10 chs. has discovered itself in the E. boundary of the Twp. which  
was run in 1873. By re-chaining the E. boundary of Sec. 1. it find  
the first half mile is but 30 chs. in length. This error by the  
former chainmen, will be confined to very few townships, as it  
is limited on the N. by the Standard, on the N. by surveys previously  
made, on the E. by the San Pedro surveys, and on the S. in a short  
distance by the Santa Rita mountains, over which lines can  
not be extended.
