

General Description, of Vulture City Town-Site,

The Town-Site of Vulture City is located on a plain sloping gently southwestward and near the foot hills of the Wickenburg Mts. The Surface is broken by several washes, and small hills or buttes.

The Soil is gravel, stony and sandy, and unfit for cultivation without artificial irrigation.

The vegetation consists of scattering Ironwood, and palo verde trees, grease wood bushes and several varieties of Cactus.

This townsite contains no Quartz ledges bearing ore, and the soil is non-mineral in character.
