CHAINS

The boundaries and subdivisional lines were surveyed by T. F. White in 1875. The east boundary was resurveyed by W. B. Kimmel in 1914. The south, west and north boundaries and a portion of the subdivisional lines were resurveyed by D. E. Harding in 1957. The east 1/2 mile between sections 4 and 33 on the south boundary was retraced by Dell Cazier in 1961. The west boundary was retraced concurrently by Louis D. Gilbert under this same Group No. and the record is included in the field notes of T. 8 S., R. 26 E.

The following field notes are those of a dependent re-survey of a portion of the subdivisional lines, designed to restore the corners in their true original location according to the best available evidence, and a retracement of a portion of the subdivisional lines in Township 8 South, Range 27 East, Gila and Salt River Meridian, Arizona.

This survey was executed in accordance with the specifications as set forth in the Manual of Surveying Instructions, 1947, and the Special Instructions dated December 24, 1968.

Only the true line bearings and horizontal distances for the surveyed lines are given in these notes. Unless described, each corner was monumented with a standard iron post, 30 inches long, 2 1/2 inches in diameter, flanged at the base, with a brass cap riveted to the top.

The geographic position of the SE. corner of the township, as determined by traverse to U.S.S.E.S. triangulation station "Eleven" located in sec. 23 is: Latitude 32°41'11.2" N. and Longitude 109°31'39.7" W.

The mean magnetic declination was found to be 13° East.

Reestablishment of the Survey Executed

Beginning at the true point for the cor. of secs. 1, 2, 35 and 36 on the S. bdy. of the Tp., in a wash, 2.00 chs. wide, with 10 ft. banks, drains N. 10° W. This cor. is witnessed N. 89°58' W., 35 lks. dist., and monumented by an iron post, 2 1/2 ins. diam., projecting 4 ins. above ground, firmly set, brass cap mkd.
