The following field notes are those of the dependent re-survey of a portion of Tract 1 and the survey of Parcels 1 through 4 within section 35, Township 16 South, Range 22 East, San Bernardino Meridian, Arizona.

The Bureau of Sport Fisheries and Wildlife made a survey of a portion of the area involved in the Group for their own use in 1971. Their corner monuments were used for control in the survey of Parcels 1 through 4 in every instance where they were identified.

Parcels 1 through 4 are situated in section 35 within an area known as "Quartermaster's Depot", U. S. Military Reservation. The southerly boundaries of Parcels 2, 3, and 4 are identical with a portion of the northerly boundary of Tract 1. It was necessary to reconstruct a portion of the boundaries of Tract 1 to properly locate these parcels. Parcel 1 is established for a road right-of-way parallel to the center line of the Yuma Valley Railroad track.

The survey was executed in accordance with the specifications set forth in the Manual of Surveying Instructions, 1947, the Special Instructions dated January 7, 1972, and Supplemental Special Instructions dated April 10, 1972.

The directions of all lines were determined by AM and PM observations of the sun and refer to the true meridian. The lines were carried forward by transit methods.

The geographic position of the point of intersection of the west right-of-way line of Second Avenue with the north right-of-way line of First Street, Yuma, Arizona, as scaled from U. S. Geological Survey quadrangle "Yuma East", is:

Longitude: 114° 37.3' W.

The observed mean magnetic declination is 14° East.
