CHAINS

The following field notes are those of the dependent resurvey of the SE boundary of the Camp Goodwin Military Reservation, (abandoned), the north boundary, the subdivisional lines, the east boundary of the San Carlos Indian Reservation and the subdivision of selected sections in Township 5 South, Range 22 East, Gila and Salt River Meridian, Arizona.

The Camp Goodwin Military Reservation, (abandoned), was surveyed by Clarence H. Wallace, in 1888. The north boundary and subdivisional lines within the Camp Goodwin Military Reservation were surveyed by Clarence H. Wallace, in 1888. The east boundary inside and outside of Camp Goodwin Military Reservation was surveyed by Theodore F. White, in 1875. The San Carlos Indian Reservation was surveyed by P. Riecker, in 1883, resurveyed by C.E. Walker, in 1887 and resurveyed again by Ray Harpin and Douglas A. Cody, in 1973-74. The east boundary was resurveyed by Philip Contzen, in 1900 outside of the Camp Goodwin Military Reservation. The north boundary and subdivisional lines outside the Camp Goodwin Military Reservation were surveyed by Philip Contzen, in 1900. A portion of the subdivisional lines were resurveyed by Will C. Gabonay in 1983.

The survey was executed in accordance with the specifications as set forth in the Manual of Surveying Instructions, 1973, and the Special Instructions dated April 8, 1982, and the Supplemental Instructions dated January 11, 1985, for Group No. 634, Arizona.

The direction of the lines of this survey was determined by altitude observations on the sun and refer to the true meridian. Distances were measured with a Zeiss Elta 46 Total Station instrument.

Preliminary to the resurvey, the lines of the original survey were retraced and search was made for all corners and other calls of the record. Identified corners were remonumented in their original positions; lost corners were restored and monumented at proportionate positions based on the original record. The retracement data were thoroughly verified and only the true line field notes are given herein.

The geographic position of the southeast corner of section 25, as determined from a tie to the U.S. Coast and Geodetic Survey triangulation station "STEER", located in section 11, T. 6 S., R. 22 E., is as follows:

NAD 27 Latitude: 32°57'43.10" N Longitude: 110°02'02.83" W

The mean magnetic declination is 13 1/2° E

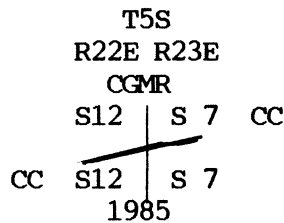
