CHAINS

The approval of these composite field notes and the acceptance of the plat, in nine sheets, will constitute the legal description and map of the Peloncillo Mountains Wilderness Area Boundary, as required by Public Law 101-628, "Arizona Desert Wilderness Act of 1990", TITLE 1, SEC. 101. (c).

This survey was executed in compliance with the provisions as set forth in Public Law 101-628, "Arizona Desert Wilderness Act of 1990".

These field notes are a composite of the approved surveys executed in the individual townships. They describe the survey of the descriptive boundary of the Peloncillo Mountains Wilderness Area Boundary in Townships 11, 12, and 13 South, Ranges 31 and 32 East, Gila and Salt River Meridian, Arizona.

For detailed information regarding the survey history of the townships, refer to the approved field notes of the individual townships.

The survey was executed in accordance with the specifications as set forth in the Manual of Surveying Instructions, 1973, and the Special Instructions dated January 6, 1992, for Group No. 739, Arizona.

For detailed information regarding monumentation and topography, the field note record for that particular township should be consulted.

The directions of all lines were determined by direct hour angle observations on the sun, and refer to the true meridian. Distances and angles were measured with a Topcon GTS3B Total Station, a Lietz Set 4 electronic instrument and a Pentax PTS-iii05 Total Station.

The geographic position of the E 1/16 section corner of sections 3 and 34, Tps. 12 and 13 S., R. 32 E., on the Peloncillo Mountains Wilderness Area Boundary, as determined by a tie to U.S. Geological Survey triangulation station "DOUBTFUL 1948", is as follows:

Latitude: 32°20'21.36" N. Longitude: 109°03'38.13" W. NAD27

The mean magnetic declination is 11 1/2° E.


