CHAINS

The approval of these composite field notes and the acceptance of the plat, in ten sheets, will constitute the legal description and map of the Mount Tipton Wilderness Area Boundary, as required by Public Law 101-628, "Arizona Desert Wilderness Act of 1990", TITLE 1, SEC. 101. (c).

This survey was executed in compliance with the provisions as set forth in Public Law 101-628, "Arizona Desert Wilderness Act of 1990".

These field notes are a composite of the approved surveys executed in the individual townships. They describe the survey of the descriptive boundary of the Mount Tipton Wilderness Area Boundary in Townships 24 North, Ranges 17, 18, and 19 West, Townships 25 North, Ranges 17 and 18 West, and Township 26 North, Range 18 West, Gila and Salt River Meridian, Arizona.

For detailed information regarding the survey history of the townships, refer to the approved field notes of the individual townships.

The survey was executed in accordance with the specifications as set forth in the Manual of Surveying Instructions, 1973, and the Special Instructions dated April 8, 1994, for Group No. 770, Arizona.

For detailed information regarding monumentation and topography, the field note record for that particular township should be consulted.

The directions of all lines were determined by direct hour angle observations on the sun, and refer to the true meridian. Distances and angles were measured with a Pentax PTS-iii05, a Sokkia SET 2BII, a Lietz Set 2A and a Topcon GTS-3B total station instruments.

The geographic position of the standard corner of sections 31 and 32, on the S. bdy. of Township 25 North, Range 17 West, on the Mount Tipton Wilderness Area Boundary, was determined by the technique of static differential positioning using Ashtech models M-XII and MS-XII geodetic units. U.S. Coast and Geodetic Survey triangulation stations "PUTMAN 1958" was used as the control station.
