

Chains Applicants for listing, J. D. Newman and Elijah J. D. Lay; Application Nos. 25 and 388, dated January 4, 1907 and November 12, 1912; List Nos. 544 and 3-2785, dated October 16, 1907 and November 24, 1913; H. E. 025165 made in the Phoenix Land Office on May 25, 1914, by Roe N. Smith.

A metes and bounds survey was resorted to in this case in accordance with the desires of the Forest Service, and in order to obtain more satisfactory lines including all possible agricultural land intended to be embraced in the original listing, while excluding Forest land. This is therefore in the nature of a cooperative survey, and will be used for a basis for substitute listing and amendment of entry. Copy of signed statement from entryman agreeing to changes made in this survey is attached at end of these notes.

Surveyed under special instructions from the Surveyor General for Arizona, dated June 13, 1916 and designated as Homestead Entry Survey No. 370.

Situated in Sec. 25, T. 19 N., R. 6 E., and Secs. 19, 20 and 29, T. 19 N., R. 7 E., Gila and Salt River Base and Meridian, within the Coconino National Forest, Arizona.

Surveyed under the Acts of June 11, 1906 and March 4, 1917.

Survey commenced May 8, 1918 and executed with a Buff and Buff transit, equipped with Smith solar attachment. I test the adjustments of the transit and make necessary corrections.

All distances are horizontal, and were reduced from measurements made directly on the slope with a 500 link steel tape. The slope angles were determined with a clinometer.
