

Also a tract of unlisted land adjoining claimant's entry was included in this survey; the land is agricultural in character, was desired by entryman and will be listed as a basis for amendment of his entry No. 024097, Surveyed under special instructions from the Surveyor General for Arizona, dated April 20, 1916, and designated as Homestead Entry Survey No. 469.

Situated in unsurveyed secs. 5 and 6, T. 29 N., R. 6 E., (partly surveyed and accepted), Gila and Salt River Base and Meridian, within the Tusayan National Forest, Arizona.

Surveyed under the Acts of June 11, 1906 and March 4, 1917.

Survey commenced October 4, 1917, and executed with a Buff and Buff transit equipped with Smith solar attachment.

I test the adjustments of the transit and make necessary corrections.

All distances are horizontal, and were reduced from measurements made directly on the slope with a 500 link steel tape. The slope angles were determined with a clinometer.

I observe Polaris for azimuth at cor. No. 1, hereinafter described. The reading on the reference object East of star is set at zero. My watch is set for local mean time.

DESCRIPTION

This claim is situated in Shad Park, which is tributary  
 to Coconino Basin.

The soil is a clay loam and at the time of survey a  
 fenced area of approximately 25 acres was under cul-  
 tivation.

There is no water on the claim.

There is a little juniper and pinon timber on the West  
 side of the place, but owing to distance from market  
 it has no commercial value.

I saw no indication of mineral upon the ground.

CONFLICTS AND ADJOINING CLAIMS

There are no conflicts. Shad Park Administrative Site  
 joins this claim on the South. H.E.S. 511 of George  
 Wilson joins this claim on North. The homestead claim  
 of George Sheley, H.E.S. No. 449, lies 1/2 mile N.  
 of this claim.

Grand Canyon, Arizona, the nearest railroad, and market  
 point and post office, lies in a Westerly direction  
 and is reached by 20 miles of good wagon road.


