We the undersigned claim for mining purposes (1500) fifteen hundred feet of this Quartz Ledge in length along the ledge or vein and three (300) hundred feet on each side of the ledge middle of the vein at the surface together with all the dips spurs and angles and all valuable mineral deposits contained therein and all timber growing within the limits of said claim and all water and water privileges thereon or appertenant thereto under and according to the provisions of an Act of Congress approved May 10th 1872 entitled "an act to promote the development of the Mining Resources of the United States."
