General Description

steep cliff on the South side upon which
the Initial Monument of the Gen Craig
is placed. This Claim contains 20.66 Acres.

The improvements consist of one Tunnel
66 ft long about 6 $\frac{1}{2}$ ft by 5 extending
into the hill on line between the Gen Craig
and Missouri also owned by James B Waller and is
said to have cost over one thousand dollars.



Notice is hereby given that the undersigned, having complied with the requirements of Chapter Six, of Title Thirty-two, of the revised Statutes of the United States, and the local laws, customs, and regulations, has, this fourteenth day of March, 1878, located fifteen hundred linear feet on this, the General Craig lode, situated in the Aytes Mining District, Santa Rita Mountains, Pima County, Territory of Arizona, and described as follows, to wit: Commencing at a stone monument, placed on the ledge, on which is a copy of this notice, and running fifteen hundred feet in a north-easterly direction, claiming three hundred feet on each side from the centre of the lode, the whole length of the claim.
