Report of Survey of Mariquitta Mine

Hon. John Wassen,

Surveyor General of Arizona

Sir,

In accordance with your letter of instructions dated May 19th 1879, I submit the following Report. On the 17th & 18th days of June 1879, I made an Official Survey of the Mariquitta Mine for Mr. Jaques Traves, Situated in American Camp, Pima Mining District, Pinal County A.T. - I found the Mine as described in the Notice of Location, I first set a U.S. Mineral Monument at a very prominent point, where it can be easily seen from all points, An immense amount of work has been done on the Mine by its various owners, and not less than 2000 tons of Gold Lined Rock is now piled up on its Dumps, of this work I find that - in one Shaft which measures 150 feet deep, the last 50 feet has been done recently - as also a tunnel 25 feet long at its bottom, this work must have been done by the present Claimant, and could not have cost him less than \$1000. The Balance of the work on the Mine, would cost, at the present time not less than \$20000. to execute it, you will no doubt understand this better, when I tell you that this is the Mine once known and worked as the "Constancia Mine", and being abandoned, was relicited by the Applicant as the "Mariquitta Mine". The formation is Granite, and the Ledge appears to be a true Friese Vein, having a dip of about 10° toward the East, The Specimens I send you are perhaps a little better than the average of the Mine.

The Corners and End Monuments shall be built of Stone, 4 feet in Diameter at the base and 3 1/2 feet high, with Stake in Centre,


