Under instructions from the Surveyor General I first established a U.S. Mineral Monument on Summit of a High hill called the Belmont Hill - lying about one mile South of the top of a high Rocky hill called Washington Hill at the foot of which is found Washington Camp.

On the southern Point of this hill I drove an iron 12 inches in length into a cleft of the Rock over which I set an oak Post 6 inches square 4 1/2 feet high marked U.S. M.M. No 1 and built a monument of stones four feet high

By the original location the Silver Bell claim was made to extend 1500 linear feet along the course of the vein and 300 feet on each side of the middle thereof at the surface, but this was found to conflict to some extent with the adjoining prior locations Belmont Lot 38 A and Empire Lot 40 A they being patented. Said conflicts were adjusted however, and therefore only such portion of the Silver Bell claim as covered otherwise unclaimed ground was surveyed.


