Selecting the most prominent projection of rocks, upon the summit of this peak, I drill a hole, one inch in diameter, and one foot deep, in solid rock, into which I place a steel rod, one inch in diameter, and one foot long, and fasten it in its place, by tamping thoroughly with sand, and drillings.

I then adjust my instrument directly over the center of said steel rod, and take the following bearings, and distances:—

I then set post directly over, and upon the steel rod before mentioned, said post being 4x4 inches, and seven feet long; painted red for a distance of two feet from the top, and white the remaining five feet.

Painted upon the red surface, with black letters, are the following:

- U.S.M.M. No. 1 —
- CALIFORNIA DISTRICT —
- MAXSON'S PEAK —

Around this post, I built a monument of rocks, six feet in diameter, across the base, and four feet high upon the post.

The variation of the needle upon my instrument, I ascertained, by an observation on "Polaris" when it was in a vertical plane with "Alloth", and found it to be  $11^{\circ}25'$  East.

## General Description.

The Chiricahua Chief Mining Claim is situate upon a mesa, or slope of land raising at a considerable degree of elevation, from the west bank of Turkey Creek; at a point about three, <sup>and three fourths</sup> miles up the creek, from its mouth, which empties into San Simon Valley; said creek being upon the east slope of the Chiricahua Mountains, <sup>and</sup> about 30 miles north of the dividing line, between the United States <sup>and</sup> Mexico; and in Cochise County, Arizona.

The improvements made by the claimant consist of Two cuts - One Shaft - One Smelter - and several houses occupied by persons employed upon the mines.

"Cut 1" was begun upon the "Chiricahua Chief" mining claim, <sup>and</sup> is six feet wide. At about 15 feet they crossed the crest and line, of the claim being then 4 feet below the surface.

"cut 2" is merely a prospect  
hole, uncovering the ledge  
being 4 x 6 ft. and 2 ft deep.

The shaft was begun some time

erations had been resumed  
again upon the shaft.

The Smelter has a capacity  
for crushing thirty tons of  
ore per day, and is built  
on the side of a hill, where  
a considerable amount of  
grading was necessary to form  
a good foundation. The main  
building is 40 x 70 feet.

It is nearly completed, and  
will be in operation in a few  
days, if no accident occurs.

The houses were built for the  
accommodation of the laborers  
employed, and are situated  
near the west end of the  
mine.
