Mineral Monument N^o 1, Helvetia
mining District, situate on the
Western slope of the North end of
the Santa Rita mountains,
Pima County, Arizona —

On the summit of the Omega
Hill (lime capped) the most
prominent accessible one in
this portion of the Helvetia mining
District, and located in the center
of a large group of mining claims.
I drive a steel bar 4 feet long
 $1\frac{1}{2}$ ins. dia. 2 feet into the lime
rock and by the side of the bar
I set a well seasoned oak post
8 feet long 4 inches squared,
marked U. S. M. M. N^o 1. H. D.
the letters cut in $3\frac{1}{2}$ ins long.
around this post I build a
monument of lime rock of the
following dimensions. The 4 sides
at base each five feet & four inches.
The 4 sides at Top, each 3 feet.
