In accordance with an agreement made on the twentieth day of July 1881. between the San Pedro Mining Company, and the Vizina Consolidated Mining Company, and recorded in Miscellaneous records, Book 1 page 171 of records of Cochise County Arizona, (to avoid any conflict between the claims) and by the request of the Superintendent of the San Pedro Mining Company.

I have departed from the direct line from the S. E. Corner of the "Survey" Claim to the N. E. Corner, and original Corner.

Dear Sir:

In pursuance to your
instructions of 28th of July 1881.

I have made an official survey
of the "Survey" Mining Claim.

I adjusted Transit to the
established Standard Meridian
and carried all lines of measured
horizontal angles through the entire
survey.

The south end line of "Survey"
being the North end line of the "Tough
Nut" Lot No. 41, I find to be $N 41^{\circ} 31' E$
instead of $N 41^{\circ} 52' E$ as given in the
field notes from your office.

This difference may arise from
the "Toughnut" being surveyed prior to the
establishing of the U. S. Standard Meridian
from which this survey was made.

The San Pedro Mining Company have
abandoned that part of Claim which
would have conflicted with the
"Virina" Mine Lot No. 59 and the "Yekka"
Lot No. 60. If a direct line had been
run from the S. E. Cor. to the N. E. Cor.
of Survey, by an agreement on record
in Recorder's office of Cochise County.

I therefore ran along the South-west-
side line of the "Virina" Lot No. 59
to its N. W. corner, and find this line
to be $N 60^{\circ} 46' W$ 1253 ft. instead of
 $N. 61^{\circ} 55' W$ 18.96 chains, as called for in the
field Notes of the "Virina" Survey.

I see no reason for this difference
except of some clerical error in

the Notes of "Virginia" Survey.

I ran $\frac{1}{2}$ within $24\frac{1}{2}$ ft. of the original North-east Corner of "Survey" Claim, to make the end lines parallel.

The North-west corner being in the traveled road and marked by a iron pin $1\frac{1}{2}$ in. in diam. and 18 in. in length, driven to surface of the ground, and a Witness post placed off the road.

The Conflict surface area of the Defense on the "Survey" claim is $0\frac{60}{100}$ Acres, and is claimed as part of the "Survey" Surface ground, which contains an Area of $17\frac{60}{100}$ Acres.

The improvements done on and within the boundaries of the "Survey" lines and by the claimants and their grantors

This Agreement, made this twentieth day of July 1881 by and between the San Pedro Mining Company, party of the first part and the Virginia Consolidated Mining Company, party of the second part, witnesseth:

That whereas the said second party has applied for United States Patents for the "Virginia", "Poor Kay" "Yreka" mining claims, situated in Tombstone Mining District, Cochise County, Arizona Territory, and is about to apply for a United States Patent for the "Poughnut No. 3", all of which mining claims are contiguous to the Survey mining claim, which is claimed by the first party; and whereas, said first party has asserted an adverse claim to a portion of the said "Virginia" mining claim and which adverse claim is now pending before the United States Land office at Tucson;

Now for the purpose of settling the said controversy concerning said adverse claim, and avoiding all future controversies between the said

parties in regard to the lines or boundaries to their respective mining claims, and for the purpose also of securing to each of said parties other rights and privileges which are hereinafter named and expressed, it is by said parties mutually agreed to and with each other, as follows:

First:

Said first party, in consideration of the sum of seven hundred and fifty dollars to be paid to it by the second party, agrees to withdraw and abandon its said adverse claim against the said Virginia mine and permit the said application of said second party for a patent to said Virginia mine to proceed without opposition, interruption or delay, according to the monuments and boundaries described in its said application for patent, and the accompanying plats and diagrams, and hereby waives and releases all claim to the ground covered by the adverse claim of the first party

and to all and every part of said
"Virginia", "Poor X", "Greka" and "Tough
nut no. 3", mines or mining claims,
as surveyed and platted by the second
party for the purpose of procuring a
patent therefor, a correct plat of which
is hereto attached, marked Exhibit "A"
and made part of this agreement.
And the first party further agrees that
the lines monuments and boundaries of
the said several mining claims, viz.:
The Virginia, Poor X, Greka, Tough
nut no. 3, and survey, as marked
and shown by said plat, Exhibit "A",
shall be taken and held as between
said parties, their successors and
assigns, as showing and marking
the true monuments, lines and boundaries
of the respective mining claims above
named, and that it will not make
or file any adverse claim, protest or
other opposition to the application now
made or hereafter to be made for United
States patent, by the second party for any
or either of its said several mining
claims.

Second:

And said first party further agrees to and with said second party, its successors and assigns, that it, said second party its successors and assigns shall and may have a right of way over that portion of the said Survey Mining Claim lying South Easterly of a line drawn from a point on the line between said Survey and Virginia Mining Claims two hundred feet north-westerly along said line from the north-west corner of said Survey mine, the same being the north west corner of the Tough Nut mine, to the South Easterly corner of said Survey mine & the same being the South West corner of said Tough Nut mine, for the purpose of conveying and moving waste from the said Virginia mine; Together with the right to build and maintain a trestle thereon for said purpose and to fill under the same and up to the level thereof with waste according to the natural slope of the waste dumped therefrom so as to use the same for the bed of the track or tramway, and also the right

to fill the ravines thereon to the level of the adjacent ground, with waste; and also for removing waste over said track onto the "Toughnut" mining claim, or any other ground they may secure in that direction, and also to use the same for conveying ore from the mines of said second party to ore bins or chutes proposed to be erected by it upon the said Toughnut mining claim; But said second party shall not have any other right or interest in the said portion of said Survey mine, last above described under this agreement than for the uses and purposes above mentioned


