"Red Cloud" Mining Claim, Mohave Co. Arizona Territory.

Sept The instrument used in this survey is a Young's Solar Transit, No. 4,901. On the night of Sept. 19th. 1881, I took an observation of Polaris on its eastern elongation, from the line thus obtained, on the morning of Sept. 20th., I set off the azimuth angle, $1^{\circ}38\frac{1}{2}'$, West, for the true meridian, which I mark and establish by cutting a cross (+) in the solid bed of rock at the point of the instrument, another cross (+) 132.8 feet South of Instrument with letters N.P. M.E.R. for North point of Meridian; and a third cross (+) on a boulder 5 ft. dia. 2.8 feet South of instrument point. The cross lines are six inches long, and are cut, like the letters, $\frac{1}{8}$ inch deep, in white, calcareous sand stone. On this Meridian, I set my instrument, after adjusting it, and find the Latitude to be $36^{\circ}10'$ North, and the Magnetic Variation $14^{\circ}54'$ East.

From the discovery monument, identified by two witnesses whose affidavit as to the identity of this survey with the claim originally located, is hereto attached, I run S. $22^{\circ}5'$ E. (Var. as above) 750 feet, to a point from which the center of the South end line, as originally located, bears: S $22^{\circ}5'$ E. 43 feet dist. Thence S. $67^{\circ}55'$ W. 300 ft., to a point where I cut a cross (+) 6 in. sq. and the letters U. S. 37, No. 1. in solid level bed of sand stone, and set a pine post, 4x4 in., 4 ft long, marked U. S. 37, No. 1 in mound of stone, 4 ft at base, and 3 ft high, for corner No. 1, and initial point of boundary line. From which original location cor. bears S $22^{\circ}5'$ E., 44 ft. dist.

From corner No. 1 I run N. $22^{\circ}5'$ W.
750 Set pine post, 4x4 in., 4 ft long, 2 ft deep, marked U. S. 37. No. 2, for corner No. 2.


From corner No. 2 I run N. $60^{\circ}13'$ W.
750 Marked a cross (+) and U. S. 37, No. 3. in solid, level bed of sand stone, and set a pine post, 4x4 in. 4 ft. long, marked U. S. 37. No 3 in mound of stone, 4 ft at base and 3 ft high, for corner No. 3. from which original location monument, bears N. $60^{\circ}13'$ W., 39 feet dist.

- 600 From corner No. 3 Run $N. 67^{\circ} 55' E.$
On edge of Sand Stone precipice, marked a cross (+) and U.S. 37, No. 4, and erected a Stone mound, 4ft base and 3ft high for corner No. 4.

Set a pine post 4x4 in. 4ft. long, 2ft. deep, marked U.S. 37, No. 5 for corner No. 5.

From corner No. 1, U.S. Mineral Monument No. 1, bears $N. 16^{\circ} 56' E. 672$ feet dist.

Description of U.S. Mineral Monument No. 1.

This monument is situated at the point of white, calcareous Sand Stone, lying between, and at the junction of, Pocket Gulch and Copper Gulch. The sand stone all around it, is of a darker (brownish) color. The point is therefore very prominent, and easily recognized. Across a cleft in the solid Sand Stone, I cut a ^{cross} crop 12 in. sq. and on the east side, cut into the rock U.S. M.M. No. 1 () at the intersection of the two lines of the crop, I also wedge in a Cedar pole, 13 ft. long, 6 in. dia. at the butt end, (tapering to 2 in.) which I also mark with a timber scribe, U.S. M.M. No. 1, and attach a red and white cotton flag, I also erect around this pole a Stone mound 3ft. base, and 4ft. high.

From this monument the North end of the Meridian line, by me established, and described at the beginning of these notes, bears $S. 6^{\circ} 35' W. 65.8$ ft. dist. The Witness cor. on South end line of Red Cloud Mining Claim, (being $S. 67^{\circ} 55' W.$ of cor. No. 6. 225 ft. distant), described in these

notes, bears $S. 16^{\circ} 49' E. 524.4$ feet dist.
There are no definite natural points with which
this monument could be connected.

General Description and "Report"

This Mining Claim is situated in Latitude $36^{\circ} 10' N.$ and Longitude about $114^{\circ} 40' W.$ of Gr., near the boundary line between Mohave and Navajo counties. About four miles east of the Shi-Wit Plateau, about six miles south of the Colorado River, about eighteen miles easterly of the "Parashant Stock Ranch," and about six miles east of "Sulphur Springs." — The vein, which occurs in sedimentary rock, (sand stone with a high percentage of lime), is of very peculiar formation. It is in the shape of an ellipse; its major axis being about 700 feet, and its minor axis about 300 feet. There are in reality some five or six veins, varying in thickness from 4 inches to over 4 feet; but the main vein varies from $2\frac{1}{2}$ to $4\frac{1}{2}$ feet, averaging about 3 feet in thickness. 


Diagram of the
