



Sir,

In accordance with your letter of instructions dated Oct 28<sup>th</sup> 1881, I have submitted the following Report. - On the 12<sup>th</sup> and 14<sup>th</sup> days of Nov. 1881. I made Official Survey of the Pacific Mining Claim, situated in Silver Mining Dist. Tuma Co. - A.T. for Franklin Black Agb and atty in fact. I found the Claim in the same condition as the Black Rock, to wit. the notes of Survey wrong by about 28" or Double the Variation, I had all the corners and Monuments identified to me by disinterested parties, and then made the Survey according to the Monuments. - The surface of the Claim is very rough and broken up, the formation Granite, the Ledge not clearly defined, but showing a probable width of 50 feet. - The work done on the Mine has been done by the Claimant and his Grantor and consists of one shaft - 6 x 6 ft 100 feet deep, with a cross cut, 6 x 6 ft 30 ft long at its bottom, and could not have cost less than \$1500. The specimens I send are good. -




Diagram of "Pacific" -
