

Field Notes of Survey of Last Chance.

Field Notes of the Survey of the Last Chance. Mining Claim. Turquoise Mining District Cochise County. Arizona.

Survey commenced April 4th 1882.
Survey completed April 17th 1882.

First.

I find by observation of Polaris. the variation of my instrument to be $11^{\circ} 20'$ East.

I commence the survey at the initial monument described in the location notice, a monument of stones in which I find a copy of the location notice. where I set a post of long & narrow sag. and build around it a monument of stones $2\frac{1}{2}$ ft high. marked T.M. Last Chance M.C. No. 1.

I then run a line through the center of the claim which line bears.

$N73^{\circ} 09' W.$

or $11^{\circ} 20'$ East.

Ascending steep side hill slopes N.E.

250. Top of ridge. slopes north. and descend,

505. And 15 ft to left. face of a tunnel of 4x6 ft. 45 ft long. center line of which bears $5^{\circ} 17' W.$

650. At Blacksmith's forge 20 ft to left of line. in sag. and ascend.

690. Gappings of ore. small cut on same,

1053. To west center monument of stones on side hill. slopes east.




