Field Notes of Establishments of U.S. Mineral

Monument No 2 - Pima Dist
Pima County A.T.

Finding no existing corners of Public Surveys in vicinity of the San Xavier Group of mines belonging to the Santa Rita Land and mining Company. I established a United States Mineral Monument upon a prominent Hill a little west of the Stone House.

I first drove a steel drill 2 ft long one inch in dia - into the Rock its full length - Then set up a pine post 8 1/2 ft high about eight inches in diameter - Squared for 2 1/2 feet at upper end - to 5 x 5 inches. Marked U.S. M. M. No 2 Pima Dist. - and built a monument of stones around it six feet in dia^{at bottom} and six feet high -



Notice is hereby given That the undersigned in compliance with the requirements of the Mining Act of Congress, approved May 10, 1872 have this day located and claimed Fifteen Hundred linear feet along the course of this lead, lode or vein of mineral bearing quartz, and Three hundred feet in width on each side of the middle of said lead, lode or vein situate in the Pima Mining District County of Pima Arizona, and more particularly described as follows, to wit: Commencing at this monument of stone being the center of the west end of claim and upon which this notice is posted. 


