Field Notes of the Survey of the Franklin
Mining Claim. Situated in Turkey
Creek Mining District, Yavapai County
Arizona.

Survey Commenced October 20th 1882.

Survey completed October 20th 1882.

Initial point, monument of location,
situated on middle of outcroppings of
vein at the centre of North end of
claim and bearing notice of location.

Direction of vein from this monument
 $S15\frac{1}{2}^{\circ}W$ Magnetic variation as obtained
by direct observation on the sun with
Burt's Solar Transit $14^{\circ}20' E$.

Beginning at the initial monument
a stone $12 \times 14 \times 40$ inches, set 1 foot
in the ground and built around
by stone mound 3 feet at base and
 $1\frac{1}{2}$ feet high marked E.N.E. and from
which Tunnel No 1 bears $S15\frac{1}{2}^{\circ}W$ 100
feet distant and Tunnel No 2, bears
 $S15\frac{1}{2}^{\circ}W$ 223 feet distant and run

They represent in the aggregate,
an expenditure of \$1770. This
claim is situated on Turkey
creek about 2 miles from
Bulky Bueno Mill. There is
no timber in the vicinity the
nearest being at the Bulky Bueno
Mill. There is no running water
in Turkey Creek. Water is easily
obtained, however, by digging a few
feet in the bed of the creek.

In running Tunnel No 1, a
nice spring of water was obtained
which will supply the wants of the
workmen for cooking, drinking and
washing purposes. The general
formation of the country is
granite.

We the under-signed claim fifteen hundred (1500) feet on this ledge, known as the "Franklin" Ledge, commencing at this Notice of Monument (built on the ledge) and running South East 300 feet to a stone monument (marked S.E. cor. of Cook & Walker's claim on the Franklin Ledge), thence South West 1500 feet to a monument (marked S. 


