Know all men by these presents:

That we the undersigned have this day located Eight Hundred (800) linear feet more or less of this vein or lode, bearing precious metals, with all dips spurs angles and variations, with surface ground Three Hundred (300) feet on each side of the centre of vein with all mineral deposits contained therein and all timber growing within the limits of said claim, and all water and water privileges thereon or appertenant thereto, under and according to the provisions of the Mining laws of the United States under which it is located,

This Claim commences at this monument and Notice placed upon the ledge and runs Eight Hundred (800) feet more or less in a Southerly direction along the ledge.

The Exterior boundaries are as follows viz: Commencing at this Monument and Notice and running three hundred (300) feet in an Easterly direction to monument of stone at N.E. corner of Claim, thence in a Southerly direction parallel with the ledge Eight Hundred (800) feet more or less to monument at S.E. Corner of Claim; thence at right angles across the ledge in a Westerly direction six hundred (600) feet to monument at S.W. Corner of Claim; thence parallel with the lode in a Northerly direction Eight Hundred (800) feet to monument at

N.W. Corner of Claim; thence at right angles across the ledge in an Easterly direction three hundred (300) feet to monument upon the ledge and place of beginning.


