The "Mowry" mining claim is located about 5 Miles in a north easterly direction from the City of Pinal near the foot of Horumans grade in Pioneer Mining Dist. Pinal County, Arizona Territory at an altitude of about 3849 feet above the level of the sea. This claim is located on the westerly slope of the hill with a surface entirely barren of timber. The vein dips towards the north at an angle of about 84°. The hanging wall consist of porphyry and the footwall of Granite.

The workings done on the claim by the applicants and grantors is as follows:

Amended Notice of Location.

Whereas the mining claim commonly designated as the "Mowry" and situated in Pioneer Mining District County of Pinal Territory of Arizona was on the fourth day of October 1876 by H. C. Jasper, A. 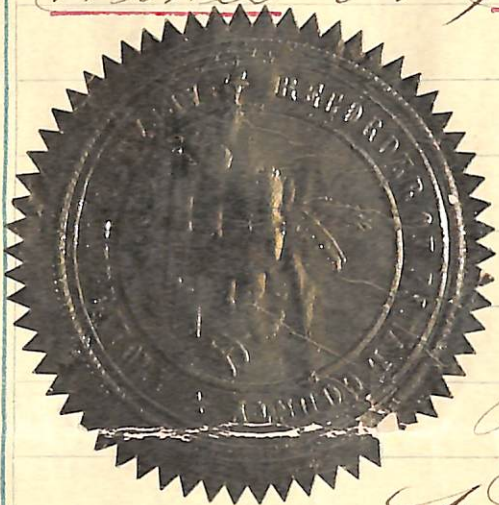

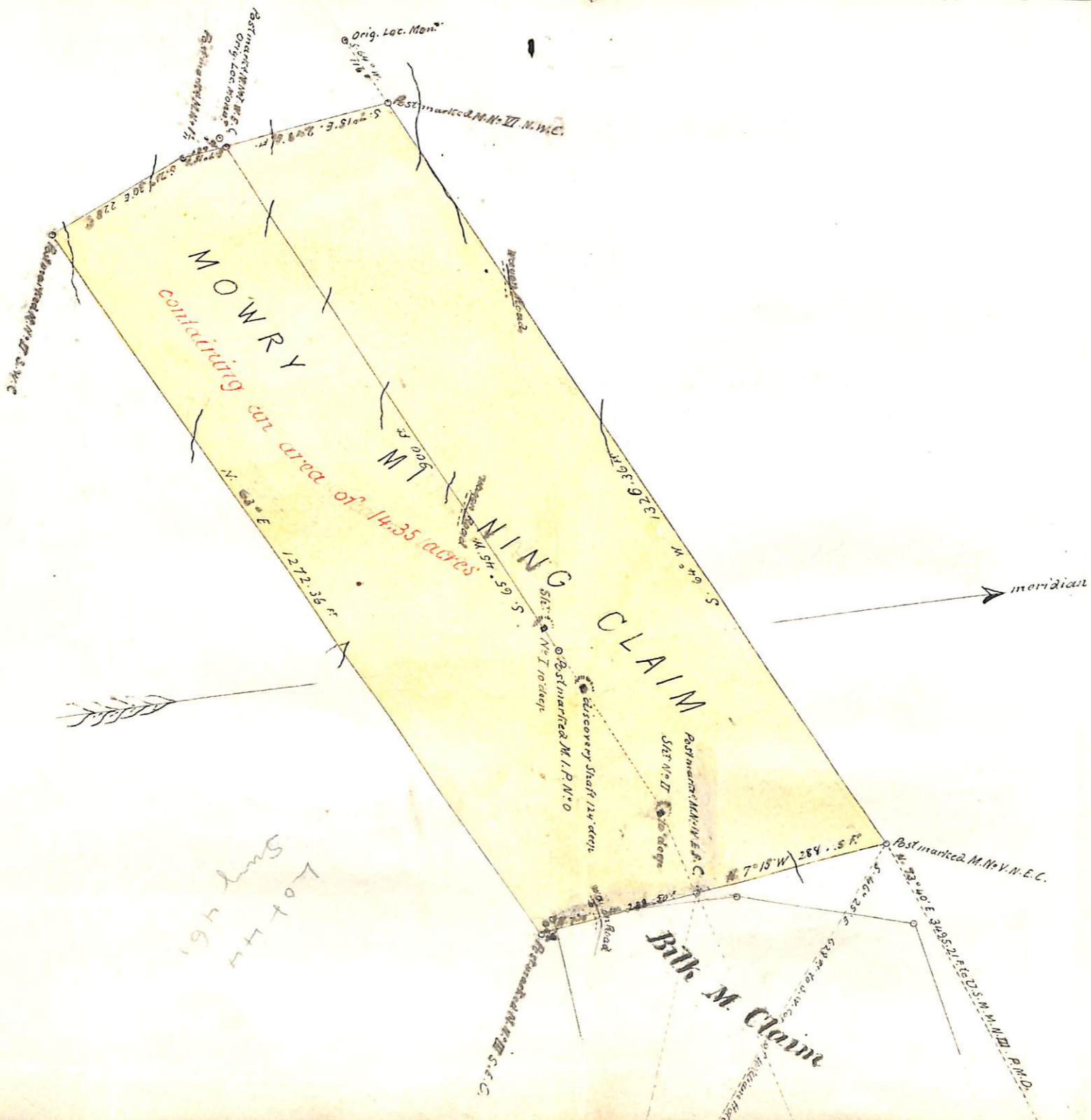
