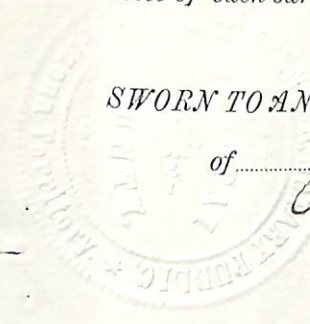

Notice of Location: Know all men by these presents that the undersigned have this day located Fifteen Hundred (1500) linear feet of this vein or lode bearing precious metals with all dips, spurs, angles and variations with surface ground Three Hundred 300 feet on each side of the center of vein, with all mineral deposits contained therein and all timber growing within the limits of said claim and all water and water privileges thereon or appurtenant thereto under and according to the provisions of the United States Mining Laws under which it is located.

This claim commences at this monument and notice, placed upon the vein and this monument containing this notice is the North center monument of said claim.

The Triangle vein lode or deposit runs in a southerly direction from this monument and the exterior boundaries are built of stone and are 300 feet on either side of the initial monument and 300 feet on either side of the end center monument on the South end of claim.

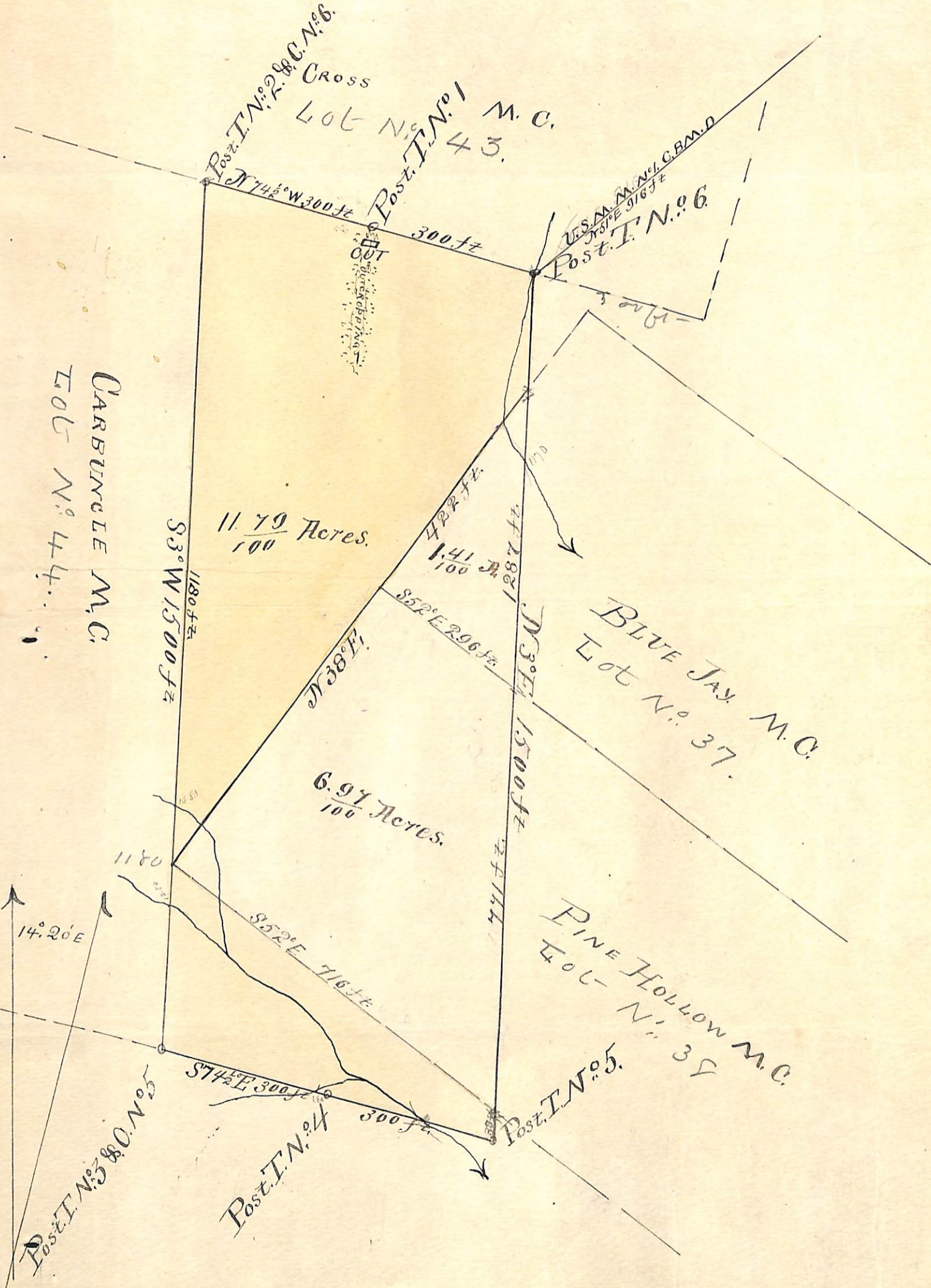
