Notice is hereby given that I the undersigned a citizen of the United States in conformity with the Mining Act of Congress Approved May 10 1872 and the Territorial and local laws of this District hereby locate and claim 1500 linear feet in length by 300 feet in width on each side of the center of the vein, along a ledge or lode of mineral bearing rock or quartz, said ledge or lode is in Globe Mining District, Pinal Co.
