-Description of Survey-

I set a flag at the South
center end of the Silver Plume
Mining Claim Lot No. 65,
as this point is described as
the North East center of the
Rattling Boy mining claim.
I then go to the South-West
center monument and to make
sure that this is the South

west center monument, pull down the monument and discover pieces of paper weather worn and water stained. I put these pieces together and find they describe this monument as the North west corner of Grand Hoop and south center of the Battling Boy mining claim:-

I then commence at this monument and find the center line of claim to bear $N 6^{\circ} 25' E$.

Notice of Location. In pursuance of an Act of Congress dated May 10th 1872 the undersigned have this day located and claimed (1500) fifteen hundred linear feet of this ledge lode or deposit of mineral bearing ore, with (300) three hundred feet in width on each side thereof, situated and described as follows, to wit: Commencing at this notice and monument of stones which is set near place of discovery & running (325) three hundred and twenty five feet in a north easterly direction to a monument of stones and from this notice and monument of stones (1175) eleven hundred and seventy five feet in a south westerly direction to a monument of stones.
